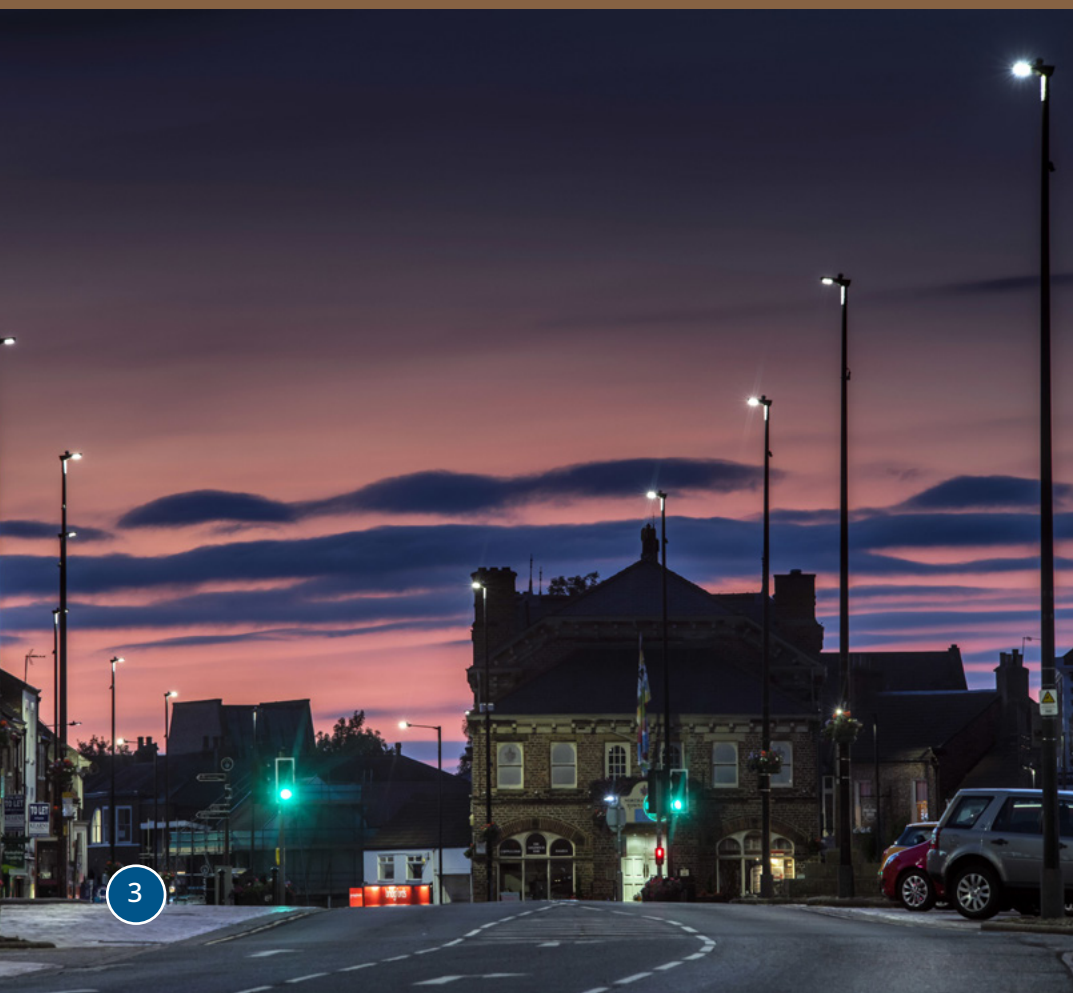


North Yorkshire council is responsible for collecting council tax and this leaflet explains how the council tax system operates and how the money raised is used.



What is Council Tax?

North Yorkshire Council must set a level of council tax to raise sufficient income to meet the expenditure requirements of providing its services. The council receives a share of government grant and a contribution from the business rate retention scheme. These receipts are deducted from the council's net expenditure requirement leaving the balance to be collected as council tax.



Calculating the Total Council Tax

North Yorkshire Council is required to collect £454.532 million of council tax to enable it to provide its services to the public.

The Police, Fire and Crime Commissioner for North Yorkshire and parish and town councils also request North Yorkshire Council to collect money on their behalf.

Including the elements above, in 2024/25 people who live in North Yorkshire will pay £561.629 million in council tax.

Council Tax bands

Your council tax demand notice is based upon your council tax banding figure which relates to the capital value of your property in 1991. Based on the value of your property on 1st April 1991 your home has been allocated to one of eight possible bands. These council tax bands are then used to determine the level of council tax you need to pay.

The amount of council tax payable by a resident is calculated by dividing each requirement (precept) by the number of properties in the relevant area that are equivalent to a Band 'D'. In 2024/25 the overall number of Band D equivalent properties is 246,009.69

The tax you then pay for other bands is calculated on 9ths of a Band D property. So, for example, a Band A property would pay 6/9th (i.e. two thirds) of the Band D amount and a Band H 18/9ths (i.e. double) the band D figure.

There is a legal requirement for councils to charge the same core council tax rate for all properties in the same council tax band.

However, for areas like North Yorkshire going through local government reorganisation the law allows an extended period to harmonise to a common rate.

North Yorkshire County Council decided that a two year harmonisation period was the most appropriate. This meant that for 2023/24 council tax differed depending upon which former district council area the property is in. For 2024/25 the North Yorkshire Council element of council tax will be the same (per band) for all areas.

It is important to remember though that the increase compared with the previous year will vary depending on whether you were in an area paying more or less than the average. *

Special Expenses

Special Expenses are charges to specific parts of the local authority's area rather than the whole. In the case of North Yorkshire these relate to a legacy arrangement from the former Ryedale District Council whereby it undertook the management of street lighting in particular areas of the district. The special expenses are a specific charge to the residents of the parishes concerned and are estimated as follows:

Charter Trustees

Charter trustees are set up to maintain the continuity of a town charter after a borough council has been abolished until such time as a parish council is established. This relates to both Harrogate and Scarborough after the creation of the new North Yorkshire Council. The charter trustees are made up of local councillors representing wards within the boundaries of the towns. The estimated costs, covering administration and specific civic duties, are shown in the table below. In 2023/24 these were funded through special expenses but this arrangement only applies in the first year after reorganisation and from 1st April 2024 the charter trustees will become local precepting bodies similar to a parish or town council.
