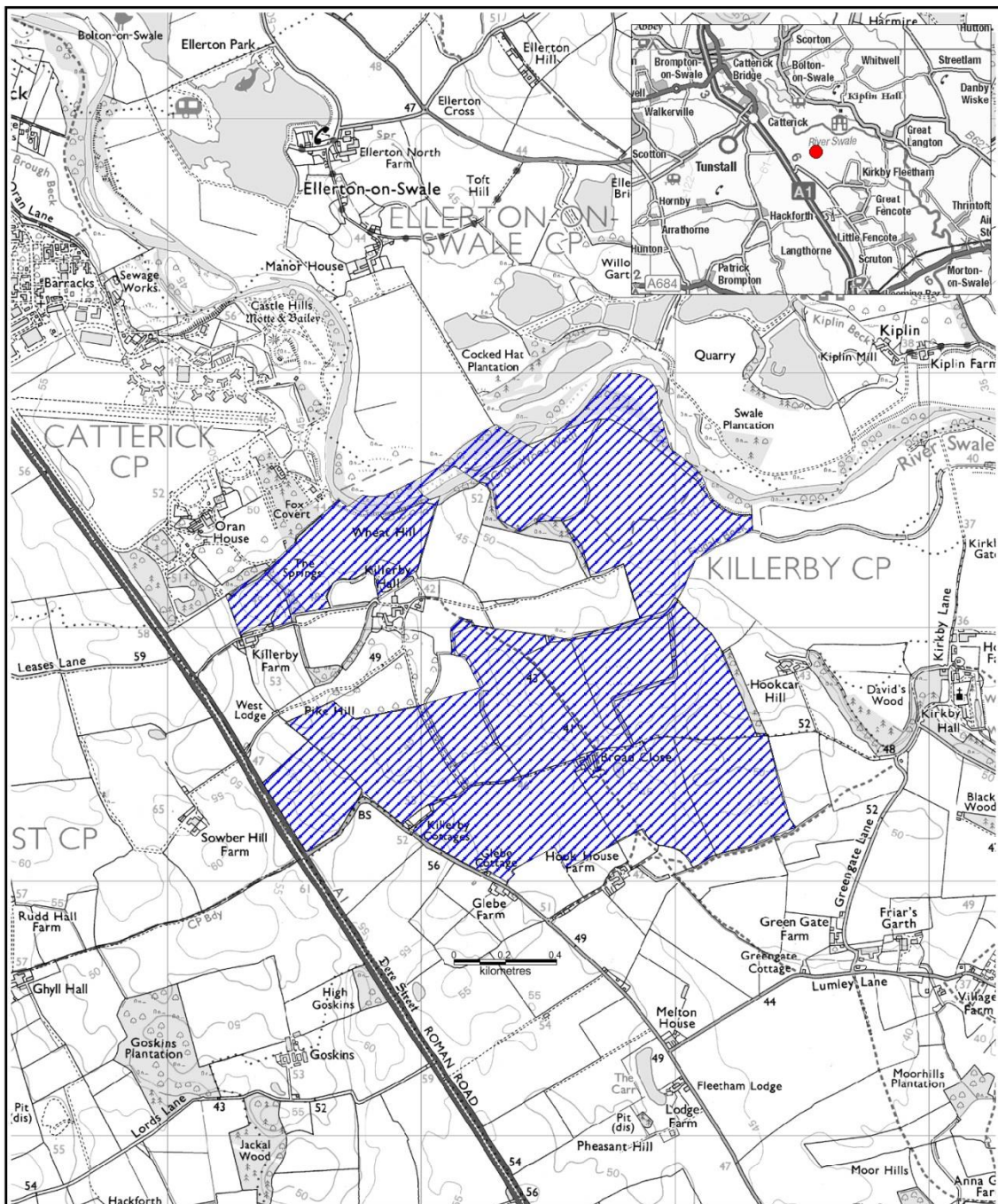


New or revised site allocations to accompany the Main Modifications.

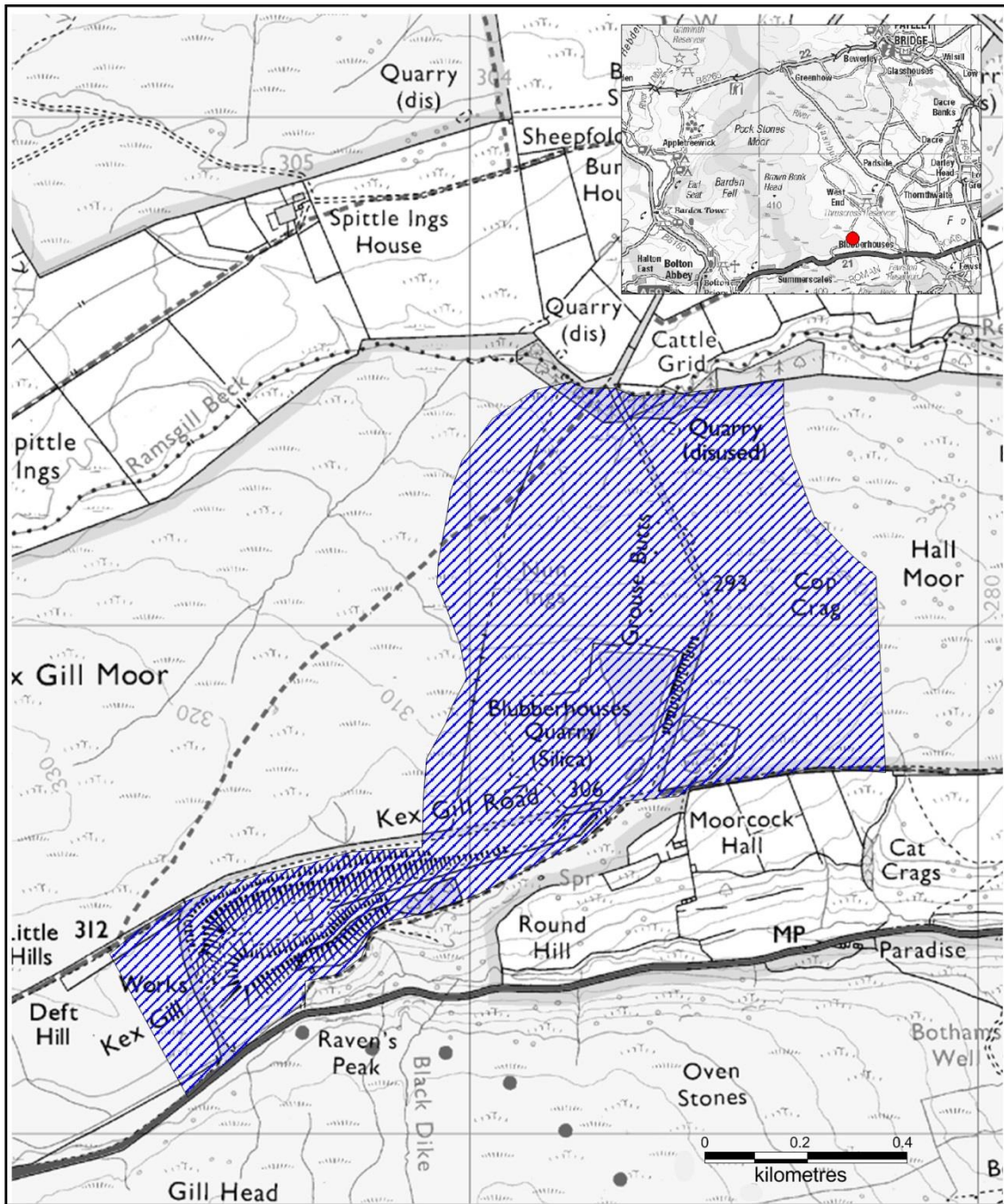

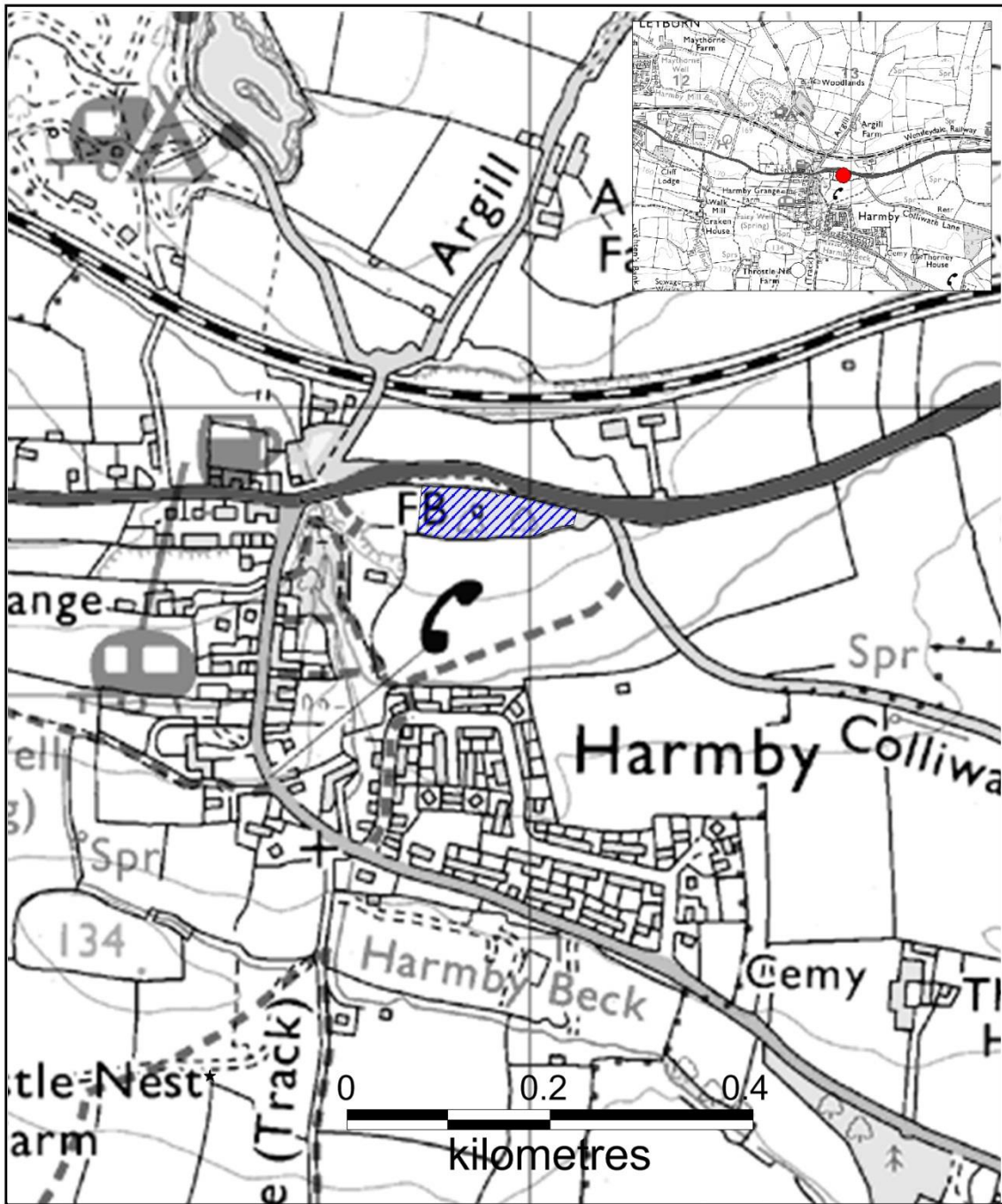

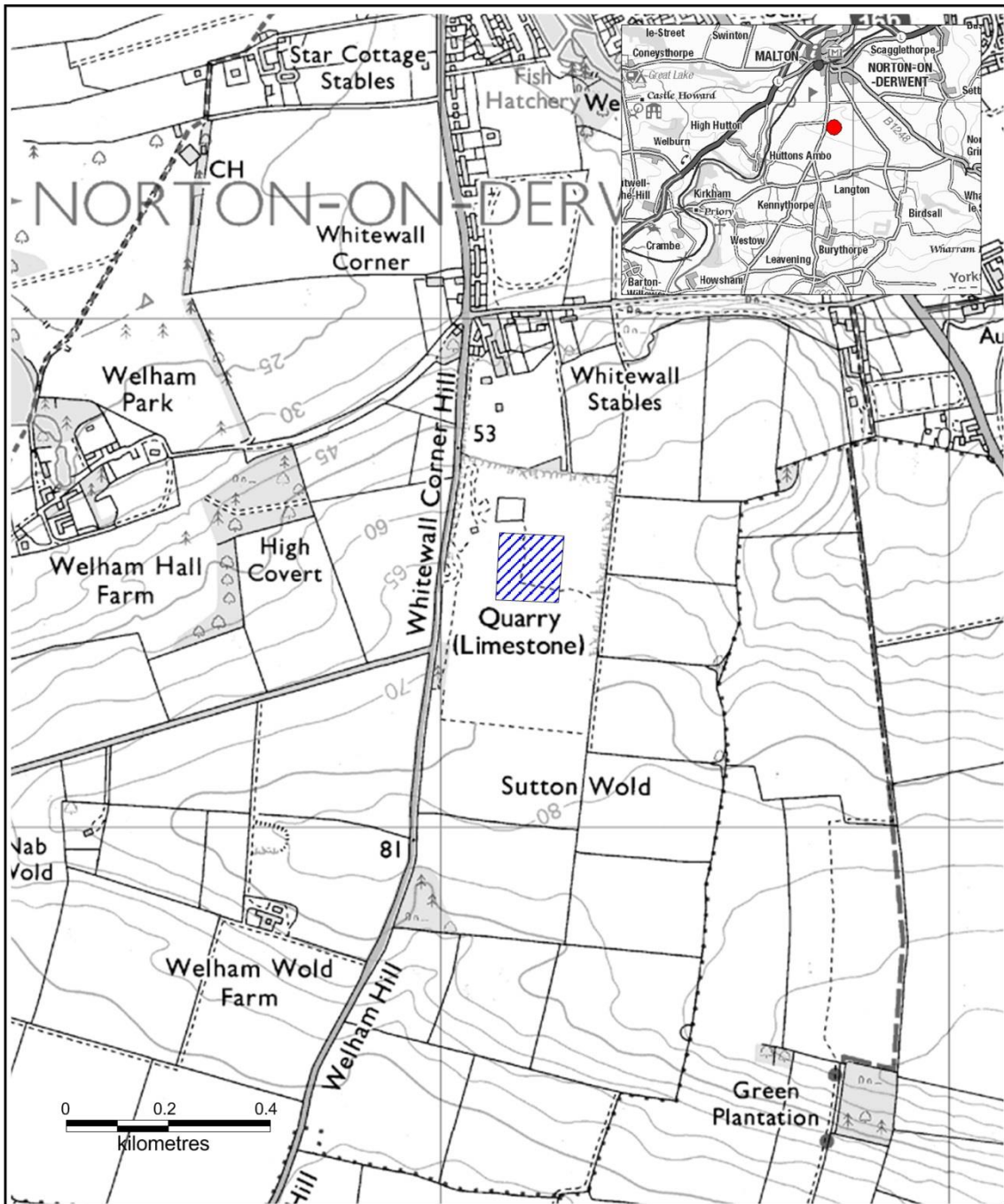

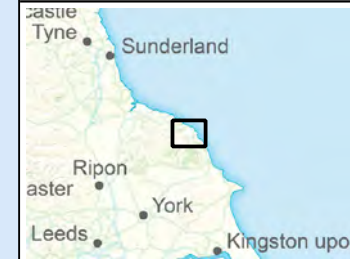
