

List of respondents to Publication document

All individuals, businesses or organisations that have been consulted about the Minerals and Waste Joint Plan have their details included in a consultation database, and are each allocated a unique 'respondent number'. At each stage of consultation on the Plan all contacts held in the database are automatically consulted. However, not all the groups, individuals, businesses and organisations that are held on the database necessarily respond to each consultation.

A total of the 200 individuals businesses or organisations responded to the Publication draft Plan. At the point of receipt of the response each 'respondent' was sent an Acknowledgement Letter containing their unique 'Respondent Number'. These are shown in the table below together with the name of the respondent, where there is a number followed by a blank name field this indicates that the respondent is an 'individual' and for Data Protection Purposes their name has been removed.
