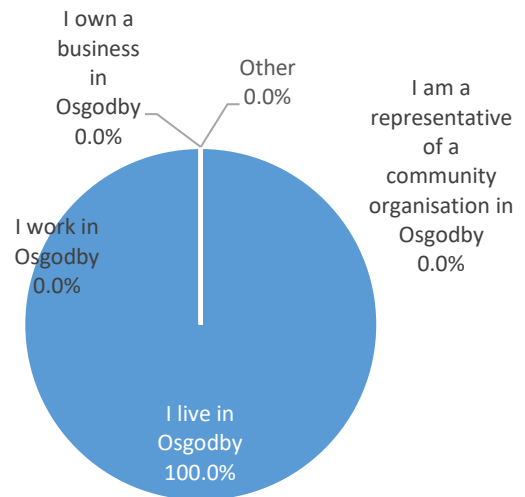

2.2.1 The options are as follows:

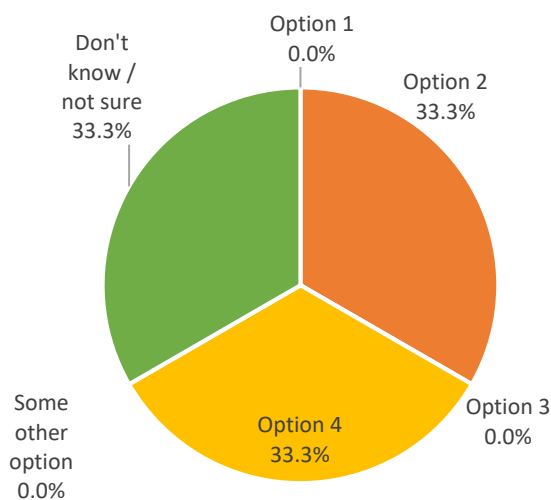
- **Option 1** - To create a parish council for the unparished part of Scarborough town centre and include the three unparished houses in Osgodby within it
- **Option 2** - The three unparished houses become part of Osgodby Parish Council and the unparished part of Scarborough town centre becomes a separate parish
- **Option 3** - To leave Scarborough town centre and the three houses in Osgodby unparished
- **Option 4** - The three unparished houses become part of Osgodby Parish Council and the unparished part of Scarborough town centre remains unparished

2.2.2 Which of the above options is your preferred option?

The responses are split between option 2 - The three unparished houses become part of Osgodby Parish Council and the unparished part of Scarborough town centre becomes a separate parish, option 4, the three unparished houses become part of Osgodby Parish Council, and the unparished part of Scarborough town centre remain unparished with 33.3% and don't know / not sure also with 33.3%. No respondents prefer options 1 and 3.

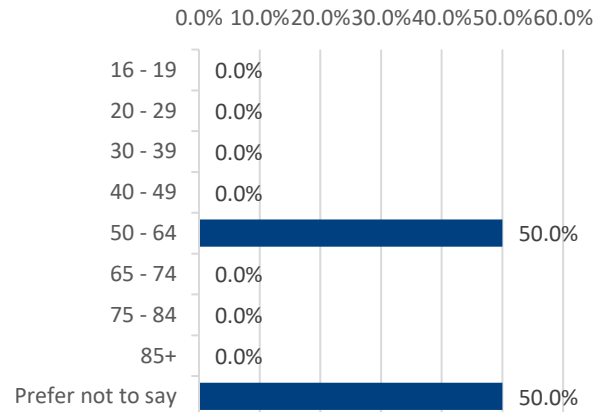
