## (PROHIBITION OF DRIVING EXCEPT FOR ACCESS) SCORE RAY LANE, WHIXLEY ORDER 2023

North Yorkshire County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1(1), 2(1), 2(2) and 3(2) of the Road Traffic Regulation Act 1984 ("the 1984 Act") and Part IV of Schedule 9 to the 1984 Act and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby make the following Order:-

1. Save as provided in article 2 of this Order no person shall except upon the direction or with the permission of a Police Constable in uniform cause or permit any motor vehicle to proceed along the C277 Score Ray Lane, Whixley as detailed below:

Road	Length
C277 - Score Ray Lane, Whixley	From the eastern extent with the B6265, for 85 metres from this point in a westerly direction.

- Nothing in article 1 of this Order shall render it unlawful for any motor vehicle to proceed along the road therein specified if the vehicle is being used:-
  - (a) for fire brigade, police, or ambulance purposes;
  - (b) (i) in connection with any wedding or funeral taking place from or at premises fronting that road;
    - (ii) in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of that road or any part thereof or the laying erection alteration or repair in that road or in land accessible only from that road of any sewer or of any main pipe, cable or apparatus for the supply of gas water or electricity or of any electronic communications network or electronic communications service as defined in Schedule 3A and Section 32 of the Communications Act 2003;
    - (iii) in the service of a Local Authority or Water Authority in pursuance of their statutory powers and duties;
    - (iv) for the purpose of conveying persons goods or merchandise to or from premises or land adjacent to that road,

and cannot conveniently be used for such purpose in any other road.

- 3. The Council are satisfied that it is requisite that Section 3(1)(b) of the Act should not apply in relation to this Order for the following reasons:
  - i. For avoiding danger to persons or other traffic using the road, or for preventing the likelihood of any such danger arising,
  - ii. for improving the amenities of the area through which the road runs,
  - for preventing the use of the road by vehicular traffic in a manner which is unsuitable having regard to the existing character of the road.
- 4. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any Order or regulations made or

having effect as if made under the Act or by or under any other enactment.

5. This Order shall come into operation on 31 March 2023 and may be cited as "North Yorkshire County Council (Prohibition of Driving Except for Access) (Score Ray Lane, Whixley) Order 2023".
