NORTH YORKSHIRE COUNTY COUNCIL (HARROGATE, KNARESBOROUGH, PANNAL AND BURN BRIDGE) (PARKING AND WAITING) (N0 23) ORDER 2016

North Yorkshire County Council (hereinafter referred to as "the County Council") in exercise of their powers under Sections 1(1), 2(1) to (3), 4(2), 32(1), 35(1) and 45 to 49 of the Road Traffic Regulation Act 1984 and Part IV of Schedule 9 to the 1984 Act and under the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- 1 This Order shall come into operation on 7 November 2016 and shall be cited as "North Yorkshire County Council (Harrogate, Knaresborough, Pannal and Burn Bridge) (Parking and Waiting) (No 23) Order 2016".
- 2 The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
 - (1) In this Order the following expressions have the meanings hereby respectively assigned.

"2004 Act" means the Traffic Management Act 2004.

"2000 Regulations" means The Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000.

"A person authorised by the Council" means a police constable in uniform, a civil enforcement officer or a person who has been issued by the County Council or Borough Council with a written authority

"Ambulance" means a vehicle which;

- (a) is constructed or adapted for, and used for no other purpose than, the carriage of sick, injured or disabled people to or from welfare centres or places where medical or dental treatment is given; and
- (b) is readily identifiable as a vehicle used for the carriage of such people by being marked 'Ambulance' on both sides.

"Approved Method of Payment" means 'pay by phone' or by credit/debit card facilitated by on street or remote verification or by pre-payment card;

"Borough Council" means the Harrogate Borough Council;

"Bus" or "Buses" means a vehicle which is constructed or adapted to carry more than eight seated passengers in addition to the driver;

"Business parking permit" means any occupant of business premises who at the discretion of the Borough Council has been issued with a permit authorising the use of a specified parking place

"Carriageway" means that part of the Road over which the public have right of way for the passage of Motor Vehicles and excludes any way over which the public have right of way on foot only;

"Cause" includes permit;

"Charge" means the payment for a parking ticket or Permit during the Charging Hours

"Charge Certificate" means the statement that the penalty charge has been increased in accordance with Regulation 21 of The Civil Enforcement of Parking Contraventions (England) General Regulations 2007;

"Charging Hours" means those hours and on those days during which parking for payment is in operation;

"Civil Enforcement Officer" means a person employed by the Borough Council for the enforcement of road traffic contraventions;

"Coach" means a passenger vehicle constructed or adapted to carry more than 16 seated passengers with a maximum gross weight exceeding 7.5 tonnes and with a maximum speed exceeding 60 mph;

"Column" means a Column in a Schedule or Part of a Schedule referred to or last referred to;

"Controlled Hours" means those hours and on those days during which there are limitations on parking, waiting, loading and unloading;

"County Council" means the North Yorkshire County Council;

"Cycle Track" has the same meaning as in Section 329 of the Highways Act 1980;

"Delivering" and or "collecting" in relation to any Goods includes checking the Goods for the purpose of their delivery or collection;

"Disabled Person" means a person who holds a disabled persons' badge in accordance with the provisions of the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 (No. 682) (and in particular Regulation 4 thereof) or any re-enactment thereto;

"Disabled person's badge" has the same meaning as in Regulation 2 of the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000;

"Disabled Person's Vehicle" means a vehicle driven by a Disabled Person as defined in Regulation 4(2) of the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 (No. 682);

"Disc Parking Place" means a Parking Place reserved for vehicles displaying a Parking Disc.

"Driver", in relation to a vehicle left in a parking place means the person driving the vehicle at the time it was left in the parking place;

"Electronic communications apparatus" has the same meaning as in Schedule 2 to the Telecommunications Act 1984;

"Enactment" means any enactment whether public general or local, and includes any order, by law, rule, regulation, scheme or other instrument having effect by virtue of an enactment;

"Goods" shall mean items of any description which cannot easily be carried by one person and do not include Goods that are not pre-ordered, shopping, small fragile Goods or cash or other valuable securities which are being collected or delivered from a bank/building society (except in the case of security company collections);

"Goods Vehicle" means a motor vehicle constructed or adapted for the carriage or haulage of Goods or burden of any description (other than the effects of passengers) or a trailer so constructed or adapted whether or not such Trailer may by superimposition be attached to the Motor Vehicle in such a manner as to cause a substantial part of its weight to be borne by the Motor Vehicle; "Hackney Carriage" has the same meaning as in section 38 of the Town Police Clauses Act 1847 as referred to in The Local Government (Miscellaneous Provisions) Act 1976 save further that reference to "plying for hire" shall be excluded from this definition; and "Taxi" shall be construed to the extent that these terms are interchangeable;

"Heavy Commercial Vehicle" means any goods vehicle which has an operating weight exceeding 7.5 tonnes as defined in Section 138(1) of the 1984 Act

"Heavy Goods Vehicle" means a Goods Vehicle with a maximum gross weight exceeding 7.5 tonnes which is constructed or adapted to carry or haul Goods of any description or which is fitted with a special appliance, plant, machinery or apparatus, such appliance plant machinery of apparatus being included in the weight or, for the purposes of this Order, a 'Heavy Commercial Vehicle' as defined in section 138 of the 1984 Act;

"Higher Level Contraventions" are as defined in The Civil Enforcement of Parking Contraventions (Guidelines on Levels of Charges) (England) Order 2007 or any amendment or re-enactment thereof;

"Household" means any self-contained unit of domestic living accommodation which contains sleeping, cooking, washing and toilet facilities;

"Invalid Carriage" has the same meaning as in Section 136 of the 1984 Act;

"junction" means, unless otherwise indicated in this Order, the intersection of the general alignment of the boundaries of two road kerblines or projected kerblines of roads;

"Length" referring to a Road means a length of road described in a Schedule;

"Loading" and, or "Unloading" means when a Motor Vehicle stops to load or unload Goods and "Loaded" and "Unloaded" shall be construed accordingly;

"Loading Bay" means any area of carriageway intended for the waiting of vehicles for so long as may be necessary to enable Goods to be loaded on or unloaded from the vehicle and which is comprised within and indicated by a road marking complying with diagram 1028.4 or 1028.6 in Schedule 7 (Part 4) to the 2016 Regulations;

"Lower Level Contraventions" means all parking contraventions which are not higher level contraventions as defined in The Civil Enforcement of Parking Contraventions (Guidelines on Levels of Charges) (England) Order 2007 or any amendment or re-enactment thereof;

"Maximum gross weight" shall have the meaning ascribed to that expression by Regulation 2 (Schedule 1) of the 2016 Regulations;

"Motor Car" shall mean and include any mechanically propelled vehicle not being a Motor Cycle or an Invalid Carriage, which is constructed itself to carry passengers of which the weight unladen does not normally exceed 3500 kilograms subject always to the inclusion of the extended meaning to this term given in Section 136 of the 1984 Act (and whether or not it is being used for business purposes);

"Motor Cycle" and "Invalid Carriage" have the same meanings respectively as in Section 136(4) of the 1984 Act;

"Motor cycle" means a mechanically propelled vehicle with less than 4 wheels and an unladen weight not exceeding 410 kilograms as defined in the Road Vehicles (Construction and Use) Regulations 1986;

"Motor vehicle" has the same meaning as in Section 136 of the 1984 Act;

"Officer" means an Officer of the County Council or Borough Council duly authorised for any purpose; "Owner" in relation to a Motor Vehicle means the person by whom such Motor Vehicle is kept and used;

"Paragraph" means a paragraph of the Article in which the word appears unless otherwise stated;

"Parking Charge" means the applicable charge payable for parking in a parking place;

"Parking Disc" means a valid disc issued by a local authority 125 millimetres square, coloured blue and capable of showing the quarter hour period during which a period of waiting began;

"Parking Place" means the areas of road designated by this Order as a parking place for the leaving of motor vehicles and which is comprised within and indicated by a road marking complying with diagram 1028.4 or 1028.6 in Schedule 7 (Part 4) to the 2016 Regulations or otherwise authorised by the Department for Transport;

"Parking Services Manager" means an Officer for the time being appointed to that post by the Harrogate Borough Council;

"Parking ticket" means a ticket dispensed by a parking ticket machine on the payment of the parking charge or issued by a civil enforcement officer on the payment of the parking charge;

"Parking ticket machine" means any apparatus or device installed to facilitate collection of the parking charge and to dispense numbered tickets as evidence of payment of the parking charge and of the time of issue of the parking ticket (or evidence from which that information can be deduced);

"Passenger Vehicle" means a Motor Vehicle (other than a Motor Cycle, an Invalid Carriage, Goods Vehicle or Heavy Commercial Vehicle) as defined in this Order;

"Pay by Phone" means a method of payment of the initial charge involving registration of payment by phone or electronic means and on first use registration of the relevant registration number of the vehicle, location of the Parking Place, Credit or Debit card details or any such details as the Council may from time to time require which is accepted by the Council as a valid method of payment at the time of use of the Parking Place;

"Penalty Charge" shall mean a charge set by the Council in accordance with The Civil Enforcement of Parking Contraventions (Guidelines on Levels of Charges) (England) Order 2007 and the provisions of Part 6 and Schedule 9 the Traffic Management Act 2004;

"Penalty Charge Notice" means a notice issued or served by a Civil Enforcement Officer or posted by the Borough Council pursuant to the provisions of Section 78 of the 2004 Act and The Civil Enforcement of Parking Contraventions (England) Regulations 2007;

"Permit" means a non transferable permit for a specified motor vehicle for residents, businesses, visitors or other persons as the case may be authorising the use of a specified parking place for the parking of a motor vehicle in a parking place, improper use of which will render the permit void;

"Permit Holder" means a person to whom a permit has been issued authorising the use of a parking place or any other person to whom the Council has issued a permit authorising the use of that parking place;

"Post office" and any reference to "post office vehicle" or "postal packets" shall be construed in the context of the Postal Services Act 2000 and the Consequential Amendments Order 2001 (No. 2001/648) and shall include therefore references to "universal service providers", as the context shall require;

"Public service vehicle" means a vehicle as defined in Section 1 of the Public Passenger Vehicles Act 1981;

"Quarter Hour Period" means a period of quarter of an hour starting at any hour or fifteen, thirty or forty-five minutes past the hour which can be shown on the Parking Disc;

"Reduced Penalty Charge" means a charge set by the County Council in accordance with charges set by the Secretary of State under the provisions of Section 77 and Schedule 9 of the 2004 Act and The Civil Enforcement of Parking Contraventions (Guidelines on Levels of Charges) (England) Order 2007 which is to be paid to the Borough Council within 14 days following the date of service endorsed upon the Penalty Charge Notice in the manner set out in the Penalty Charge Notice;

"Registered Keeper" means:-

- (a) the person whose name appears in the Motor Vehicle registration document or book of the Motor Vehicle in whose name the vehicle is registered, or
- (b) a person who has the permanent use of the Motor Vehicle vested in the name of his employer, or in the case of a leased Motor Vehicle in the name of the leasing company;

"Relevant Position" in relation to the display of a parking ticket, parking disc or permit on a vehicle means –

- (a) if the vehicle is fitted with a front windscreen facing outwards on the near side on and immediately behind the windscreen;
- (b) if the vehicle does not have a windscreen in a conspicuous position on the vehicle.

"Relevant Position" in relation to the display of a disabled person's badge has the same meaning as given in Regulation 4 of the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000;

"Resident" means a person whose usual place of abode is at premises fronting any length of Road specified in Schedules 1, holding a driving licence and who may make an application for a Household Permit for a Motor Vehicle having an unladen weight of not more than 3500Kgs;

"Residents' parking permit" means a permit issued to a resident authorising the use of a specified parking place;

"Road" means the full width of the highway including the carriageway and footway any other Road to which the public has access and includes bridges over which a Road passes;

"Season ticket" means a valid Season ticket issued by the Borough Council to a resident, business or visitor as the case may be authoristing the use of a specified parking place;

"School Keep Clear Area" means any area of carriageway outside a school entrance which should be kept clear of stationary Motor Vehicles and which is comprised within and indicated by a road marking complying with complying with diagram 1027.1 in Schedule 7 (Part 4) to the 2016 Regulations;

"Secretary of State" means the Secretary of State for Transport;

"Service" in respect of a Penalty Charge Notice means the forms of service specified in regulations 9 and 10 of The Civil Enforcement of Parking Contraventions (England) General Regulations 2007 or any amendment or re-enactment thereof;

"Taxi" means a vehicle licensed to ply for hire within the area and does not include private hire vehicles;

"Taxi rank" means an area of carriageway reserved for use by taxis plying for hire;

"Timing point" means a place where a Public Service Vehicle may wait for the purpose of synchronising its journey time with the published schedule;

"Traffic Sign" means a sign or marking of any size colour and type prescribed or authorised under, or having effect as though prescribed or authorised under Section 64 of the 1984 Act;

"Trailer" shall have the meaning assigned to it by Section 136(1) of the 1984 Act;

"the 1984 Act" means the Road Traffic Regulation Act 1984;

"the 2016 Regulations" means the Traffic Signs Regulations and General Directions 2016 (SI 2002/362);

"the 2004 Act" means the Traffic Management Act 2004;

"Universal service provider" has the same meaning as in the Postal Services Act 2000;

"Valid Permit" means a Permit issued in respect of a Motor Vehicle which has not become invalid and is not being used in circumstances where it is not valid;

"Verge" means any part of a Road which is not a carriageway, footway or lay-by,

"Zone" refers to any one of the parking zones containing the roads or lengths of roads described in Schedule 1 to this Order.

(2) Any reference in this Order to a numbered Article or Schedule shall, unless the context otherwise requires, be construed as a reference to the Article or Schedule bearing that number in this Order.

ON STREET PAY AND DISPLAY PARKING

- 4 The lengths of road which are described as parking places in Schedule 1 are on street parking places during such days and times for such classes of vehicle and for such purposes as are specified in Schedule 1 and no person shall cause any vehicle to wait or be in a parking place in contravention of this Article or any of the following Articles.
- 5 Each parking place may be used subject to the provisions of this Order for the leaving of any Motor vehicle which by reference to its size can be accommodated wholly within the limits of the parking place and so that no part of the vehicle overhangs the footway and it does not obstruct the premises adjacent to the side of the road on which the vehicle is standing.
- 6 The limits of each parking place shall be indicated on the carriageway.
- 7 The driver of a Motor vehicle shall not permit it to wait in any parking place on any of the lengths of Road specified in Schedule 1 unless it is of the class of Motor Vehicle specified in Column 3 of Schedule 1 and in such a position as specified in Article 5.
- 8 Subject to the provisions of Articles 23 and 24, a Motor Vehicle of a class specified in Schedule 1 may wait during the charging hours specified in any Parking Place in Schedule 1 for a period not exceeding the maximum permitted stay time specified in Column 4 of the Schedule, providing always that the Motor Vehicle has not previously waited in any of the parking places specified in Schedule 1 within the time period specified in Article 8 and that the parking charge, unless such charge is Nil, has been paid.

- 9 Where the Motor Vehicle has left any parking place in any of the lengths of Road specified in Schedule 1 after waiting thereon, the driver thereof shall not within 2 hours after its leaving that parking place permit it to wait again in any parking place in any of the lengths of Road specified in Schedule 1 during the charging hours.
- 10 For the avoidance of any doubt it is hereby declared that any Goods Vehicle or Heavy Commercial Vehicle is prohibited to wait in any of the parking places specified in Schedule 1 of this Order.
- 11 The parking charges that apply to any vehicle left in a parking place are as set out in Schedule 1A such charges being determined by the applicable charging zone within which the parking place is situated as indicated in Column 6 of Schedule 1 **Provided that** the charges may be amended from time to time by the County Council as determined and publicised in accordance with statutory requirements.
- 12 Payment of the parking charge may be made by way of a parking ticket machine or through an Approved Method of Payment (the provisions of Article 20 apply to such payment).
- 13 The parking charge shall be payable on the leaving of a vehicle in a parking place by the insertion into the parking ticket machine of coins or notes of the denomination marked on the parking ticket machine or through an Approved Method of Payment or such other method acceptable by the parking ticket machine (whether by debit card, credit card, telephone or otherwise) that will enable the parking charge to be paid by electronic means to the value of the relevant parking charge appropriate for that parking place having regard to the intended period of stay.
- 14 Where the parking charge is Nil, the parking charge shall be payable by obtaining a free parking ticket from the parking ticket machine or through an Approved Method of Payment or such other method acceptable by the parking ticket machine (whether by credit card, telephone or otherwise) that will enable the parking charge to be paid by electronic means to the value of the relevant parking charge appropriate for that parking place having regard to the intended period of stay.
- 15 Payment of the parking charge shall be indicated by the issue by a parking ticket machine relating to that parking place of a parking ticket showing the time and day when payment of the parking charge was made (or showing information from which this can be deduced) and an indication that payment of that parking charge has been made and by the display of that parking ticket on the vehicle in accordance with the provision of Article 16 of this Order.
- 16 A parking ticket obtained from a parking ticket machine on payment of the parking charge must be displayed in the relevant position on the vehicle for which it was issued and the said ticket must be so displayed on the vehicle so that the time and day when payment of the parking charge was made (or showing information from which this can be deduced) and an indication that payment of that parking charge has been made shown on the front of the parking ticket is clearly visible from the front of the vehicle.
- 17 The day and time shown on a parking ticket as being the day and time in respect of which the relevant parking charge has been paid shall be presumed unless the contrary is proved to be the day and time in respect of which such parking charge was paid.
- 18 If at any time while a vehicle is left in a parking place no parking ticket indicating that the relevant parking charge has been paid in respect of the day on which the vehicle is so left is displayed on that vehicle in accordance with the provisions of Article 16 of this Order it shall be presumed unless the contrary is provided that the relevant parking charge has not been paid.
- 19 A person must not exhibit on a vehicle left in a parking place during the charging hours any parking ticket relating to that parking place other than the parking ticket issued upon payment of the parking charge in respect of that vehicle.
 - A motor vehicle must not be left in a parking place during the charging hours:

(a) for longer than the period for which payment was made by the parking charge; or

- (b) without payment of the parking charge (unless such charge is Nil); or
- (c) without displaying in the relevant position a parking ticket which shows that the day of payment of the parking charge is not the day on which the vehicle was so left (in which event it will be assumed that the parking charge has not been duly paid); or
- (d) in a position which does not comply with the provisions of Article 5.
- 21 Following payment of the parking charge no person shall make a further payment by the insertion of coins, notes or through an Approved Method of Payment or such other method (whether by credit card, telephone or otherwise) in order to extend the length of time in which the vehicle may be left within the parking place.
- 22 If a parking ticket machine is out of order then a Civil Enforcement Officer may place a notice nominating another parking ticket machine in the street in which the parking place is located or in any nearby street at which the parking ticket may be obtained and that parking ticket shall be valid for the purposes of the provisions of this Order.
- 23 Subject to the vehicle complying in all respects with Articles 11-22 no parking charge shall be payable in respect of any vehicle left in a parking place during the charging hours if that vehicle displays in the relevant position on the vehicle;-
 - (a) a disabled persons badge and parking disc;
 - (b) The Driver of a two wheeled Motor Cycle not having a side car attached;
 - (c) a valid permit;
 - (d) a valid season ticket

PROVIDED THAT if the use of the parking place is suspended in accordance with Articles 27 or 28 then this proviso shall not apply.

- 24 The following motor vehicles left in a parking place on any of the lengths of road specified in Schedule 1 to this Order shall be exempt from compliance with any limitation of time during when a Motor Vehicle may be left in such a parking place specified in the foregoing provisions of this Order;-
 - (a) an Invalid Carriage;
 - (b) a Motor Vehicle issued to a Disabled Person by the Department of Health and Social Security in lieu of an Invalid Carriage;
 - (c) a Disabled Person's Vehicle which displays in the Relevant Position a Disabled Person's Badge having effect as if it were a Disabled Person's Badge;
 - (d) a motor vehicle left by the driver thereof being a Motor Vehicle which bears in a conspicuous position a Permit issued by the Borough Council, or a certificate signed by the Area 6 Highways manager of the County Council stating that the motor vehicle is exempted under this provision.
 - (e) a motor vehicle left by the driver thereof being a motor vehicle which displays in the Relevant Position a valid permit specific to the Zone reference number in which the Motor Vehicle is parked, except where the Permit applies to all Zones.
 - (f) A motor vehicle left by the Driver thereof being a Motor Vehicle which displays in the Relevant Position a Monthly Season Ticket specific to the street in which the Motor Vehicle is parked.

- 25 Without prejudice to the generality of the foregoing provisions of this Order nothing in Articles 22 and 23 shall be taken to exempt any vehicle left in any parking place from any other provisions of this Order.
- 26 Where a vehicle is standing in a parking place in contravention of the provisions of Article 5 a civil enforcement officer may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions.

Powers to suspend use of parking places

- 27 A Civil Enforcement Officer or other person duly authorised by the Borough Council may suspend the use of a parking place or any part thereof whenever he/she considers such suspension reasonably necessary;-
 - (a) for the purpose of facilitating the movement of traffic or promoting its safety;
 - (b) for preventing obstruction
 - (c) for the purpose of any building operation, demolition or excavation in or adjacent to the Parking Place or the maintenance, improvement or construction of the Parking Place or the laying, erection, alteration, removal or repair in or adjacent to the Parking Place of any sewer or of any main pipe or apparatus for the supply of gas, water or electricity or of any electronic communications apparatus or traffic sign;
 - (d) for the convenience of occupiers to premises adjacent to the Parking Place on any occasion of the removal of furniture from one office or dwelling house to another or the removal of furniture from such premises to a depository or to such premises from a depository;
 - (e) for any occasion on which it is likely by some special attraction that any Parking Place or adjacent street will be thronged or obstructed;
 - (f) for the convenience of occupiers to premises adjacent to the Parking Place at times of weddings or funerals or on other special occasions;
 - (g) to enable the Parking Place to be used for or in connection with civic ceremonies or for road safety religious charitable sporting or educational purposes;
 - (h) for any other purposes which the County Council or Borough Council considers appropriate.
- 28 A Police Constable in uniform may suspend for not longer than 24 hours the use of any parking place or any part thereof whenever he or she considers such suspension reasonably necessary for the purpose of facilitating the movement of traffic or promoting its safety.
- 29 Any person suspending the use of a Parking Place or any part thereof in accordance with Articles 27 and 28 shall thereupon place or cause to be placed in or adjacent to that Parking Place or that part thereof a notice or traffic sign indicating that the use of that Parking Place or part thereof is suspended and that waiting of vehicles is prohibited.
- 30 The Borough Council at its discretion may suspend the use of any part of a Parking Place and thereafter may designate that part of such Parking Place to be reserved for the parking of vehicles being used or engaged in the operations of the County Council, the Borough Council, the Police, any voluntary or other organisation or any statutory undertaking and any part of the Parking Place so designated shall be marked as to identify that it is reserved for vehicles engaged in such operations.
- 31 No person shall cause or permit a vehicle to be left:-
 - (a) In a Parking Place or any part thereof during such period that the use of that Parking Place or that part thereof is suspended or during such period as there is in or adjacent thereto a notice or traffic sign placed in pursuance of Article 29;

- (b) In any part of a Parking Place marked as being designated by the Borough Council in pursuance of Article 30 for the parking of vehicles engaged in the operations of the Borough Council, the County Council, the Police, any voluntary or other organisation or any statutory undertaking.
- 32 When any parking place or any part thereof has its operation suspended pursuant to Article 27 no person shall cause any motor vehicle to wait or load or unload in that parking place or part thereof for the duration of the suspension, provided that nothing in this paragraph shall render it unlawful to cause an ambulance or any vehicle being used for fire brigade or police purposes, to enter or be left in that parking place or part thereof during the period of suspension, or to any other vehicle so left, if that vehicle is displaying a valid dispensation issued by the Borough Council.

Exemptions

- 33 Nothing in this Order shall render it unlawful to cause any motor vehicle to wait in any parking place on any of the lengths of road specified in Schedule 1, if the use of that parking place has not been suspended, for a period no longer than is necessary for:
 - (a) The motor vehicle is waiting only for so long as is necessary to enable a person to board or alight from the motor vehicle or to load thereon or unload therefrom his or her personal luggage
 - (b) the motor vehicle is being loaded or unloaded while being used for the delivery or removal of furniture to or from any premises fronting on to the said parking place
 - (c) a motor vehicle directly used in connection with any of the following operations, namely:
 - (i) building, industrial or demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of any of the said lengths of Road or sides of Road; or
 - (iv) the laying, erection, alteration or repair in, or in land adjacent to, any lengths of road specified in Schedule 1 of any sewer or of any main pipe or apparatus for the supply of gas, water or electricity or of any electronic communications apparatus as defined in Schedule 2 to the Telecommunications Act 1984 and cannot be used for the purpose in any other road;
 - (d) the vehicle, not being a passenger vehicle, being used in the service of a local authority in pursuance of statutory powers or duties provided that in all the circumstances it is reasonably necessary in the exercise of such powers or in the performance of such duties for the vehicle to wait in the place in which it is waiting;
 - the vehicle to be used for the purpose of delivering or collecting postal packets as defined in Section 125(1) of the Postal Services Act 2000;
 - (f) the motor vehicle is in the service of a universal service provider and bears a livery used by a universal service provider and is waiting in the parking place engaged in the collection and or delivery of letters in accordance with statutory duties for the provision of services for the conveyance of letters
 - (g) the motor vehicle to wait at or near to any premises situated on or adjacent to said side or any of the said lengths of Road or parking place for so long as such waiting by that vehicle is reasonably necessary in connection with a funeral; or

- (h) the motor vehicle is being used for fire brigade, ambulance or police purposes; the Motor Vehicle is a Motor Vehicle being used for Fire Brigade purposes or Ambulance or a Motor Vehicle (other than a Passenger Vehicle) in the service of a local authority or a Motor Vehicle in the service of a Police Force or statutory undertaking in any case being used in pursuance of statutory powers or duties which require the Motor Vehicle to be close at hand for the purpose of such statutory powers or duties;
- the Motor Vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid an accident;
- (i) a vehicle displaying a valid waiver or dispensation.
- 34 No parking charge specified in the foregoing provisions of this Order shall be payable in respect of any vehicle waiting in a parking place in accordance with the provisions of Article 31
- 35 A person causing or permitting a vehicle to wait in a parking place by virtue of Article 31 shall take all necessary steps to ensure that the vehicle is left in accordance with Article 5

Powers to remove vehicles in parking places

- 36 Where a Civil Enforcement Officer is of the opinion that any of the provisions contained in this Order have been contravened or not complied with in respect of a vehicle left in a parking place he/she may remove or cause to be removed the vehicle from the parking place.
- 37 Where a Civil Enforcement Officer is of the opinion that any of the provisions contained in this Order have been contravened or not complied with in respect of a vehicle left in a parking place he/ she may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions.
- 38 A person removing or altering the position of a vehicle by virtue of Articles 36 or 37 may do so by towing or driving the vehicle or in such other manner as he/she may think necessary and may take such measures in relation to the vehicle as he/she may think necessary to enable him/her to remove it or alter its position as the case may be.
- 39 When a person authorised by the Borough Council removes or makes arrangements for the removal of a vehicle from a parking place by virtue of Articles 36 or 37 of this Order he/she shall make such arrangements as may be reasonably necessary for the safe custody of the vehicle.
- 40 A vehicle so removed from a parking place may be disposed of in accordance with Sections 101 to 103 of the the 1984 Act.
- 41 A Civil Enforcement Officer or a Police Constable in uniform may in the case of emergency move or cause to be moved to any place he thinks fit a vehicle left in a parking place.

Further conditions on the use of parking places

- 42 Unless prior written consent has been granted by the County Council or Borough Council no person shall:
 - (a) use a vehicle while it is in a parking place in connection with the sale or advertisement of anything to persons in or near the parking place or in connection with the selling or offering for hire of his skill or services
 - (b) use any part of a parking place with any building structure mechanical device or other physical feature therein or any vehicle left therein to display advertising material nor to place upon or attach to any vehicle in the parking place any advertising material to induce the public to participate in or frequent any place function or gathering for the purpose of demonstration or

entertainment or to buy or hire or otherwise obtain anything or the skill or services of any person and nothing shall be displayed to induce the public to engage for gain in any lottery sweepstake raffle or competition

- 43 No person shall use any part of a Parking Place or any vehicle parked in a Parking Place-
 - (a) for sleeping or camping or cooking; or
 - for the purpose of servicing or washing any vehicle or part thereof other than is reasonably (b) necessary to enable that vehicle to depart from the parking place.
- 44 During the period of operation of a parking place specified in this Order no person shall without the written consent of the Borough Council and subject to such conditions as the Borough Council from time to time decide use any vehicle while it is in the parking place, in connection with any commercial activities, or the advertisement or sale of any article to persons in or near the Parking Place, or in connection with the selling or offering for hire of his skill or services.
- The driver of a motor vehicle using a parking place on any of the lengths of road specified in 45 Schedule 1 to this Order shall stop the engine as soon as the motor vehicle is in position in the parking place and the engine shall not be started except when the position of the motor vehicle in the parking place is about to be changed or the motor vehicle is about to depart from the parking place

PENALTY CHARGE AND PAYMENT

- 46 Where a Motor Vehicle:-
 - (a) waits, parks or is left on a Road in contravention of the foregoing provisions of this Order or otherwise contravenes or fails to comply with the provisions of this Order, insofar as it relates to a Motor Vehicle waiting, parking or being left on a Road; or
 - (b) waits, parks or is left on a Road in contravention of any other Traffic Regulation Order the provisions of which are not consolidated into this Order or fails to comply with the provisions of any such Order insofar as it relates to a vehicle waiting, parking or being left on a Road; or
 - (c) parks in contravention of the provisions of Sections 19 or 21 of the Road Traffic Act 1988 (prohibition of parking of HGVs on Verges, central reservations and footways and driving or parking on Cycle Tracks);

a penalty charge shall be payable by the owner for each day of the said contravention or noncompliance.

- The penalty charge or reduced penalty charge shall be in the sum of the following amounts:-
 - (a) The penalty charge Band 2 as set out in Section 1 of The Civil Enforcement of Parking Contraventions (Guidelines on Levels of Charges) (England) Order 2007 subject to payment being received by the Council as provided in Article 51 within 28 days beginning with the date of service of the penalty charge notice.
 - (b) The reduced penalty charge a 50 per cent reduction of the penalty charge subject to payment being received by the Council as provided in Article 52 within 14 days beginning with the date of service of the penalty charge notice.
 - (c) On the issue of a charge certificate in accordance with the provisions of Regulation 21 of The Civil Enforcement of Parking Contraventions (England) General Regulations 2007 to the effect that the penalty charge in question is increased by 50 per cent.
- 48 Service of a penalty charge notice or charge certificate by post is deemed effective on the second working day after the day of posting.

- In the case of a motor vehicle in respect of which a penalty charge is payable under Article 51a penalty charge notice, which shall comply with the requirements of Regulation 9 and the Schedule to The Civil Enforcement of Parking Contraventions (England) General Regulations 2007, may be issued by a Civil Enforcement Officer and may accordingly be affixed to the motor vehicle in a conspicuous position or given to the person appearing to be in charge of the vehicle,
- 50 In the case of a motor vehicle in respect of which a penalty charge is payable under Article 51 a penalty charge notice, which shall comply with the requirements of Regulation 10 and the Schedule to The Civil Enforcement of Parking Contraventions (England) General Regulations 2007, may be issued by post by the Council if the owner of the vehicle drives the vehicle away before the Civil Enforcement Officer has issued a penalty charge notice or the Civil Enforcement Officer has been prevented from issuing a penalty charge notice.
- 51 Payment of the penalty charge to the Council shall be paid by electronic transfer, cash or by credit card or debit card, cheque or postal order in each case crossed and made payable to Harrogate Borough Council which shall be delivered or sent by post so as to reach the relevant Department/ Office of the Council as stated on the penalty charge notice not later than 4:30pm, within 28 days beginning with the date of service of the penalty charge notice, but should the said Council Department/Office be closed on that day, the period for receiving payment may be extended until 4:30pm on the next full working day. Payment may also be made in person or by phone as detailed on the Penalty Charge Notice.
- 52 Payment of the reduced penalty charge to the Council shall be paid by electronic transfer, cash or by credit card or debit card, cheque or postal order in each case crossed and made payable to Harrogate Borough Council which shall be delivered or sent by post so as to reach the relevant Department/Office of the Council as stated on the penalty charge notice not later than 4:30pm, within 14 days beginning with the date of service of the penalty charge notice, but should the said Council Department/Office be closed on that day, the period for receiving payment may be extended until 4:30pm on the next full working day. Payment may also be made in person or by phone as detailed on the Penalty Charge Notice.
- 53 The particulars given in the penalty charge notice attached to a vehicle, given to the person appearing to be in charge of the vehicle or issued by post by the Council in accordance with Articles 46 52 shall be treated as evidence in any proceedings relating to failure to pay such penalty charge.

REVOCATION OF EXISTING ORDERS

54 The Traffic Regulation Orders specified in Column 1 of Schedule 2 to this Order are hereby revoked to the extent specified in Column 2 of that Schedule, and to the extent that the provisions of this Order are inconsistent with, or incompatible with, the provisions of any other Order, Byelaws or enactment relating to traffic regulation in Harrogate, Knaresborough, Pannal and Burnbridge area not specifically referred to in Schedule 2, the provisions of this Order shall prevail for all purposes.

GENERAL

- 55 The provisions of this Order shall be subject to the exemptions for disabled persons vehicles stipulated by the Local Authorities' Traffic orders (Exemptions for Disabled Persons) (England) Regulations 2000.
- 56 The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any Order or regulations made or having effect as if made under the 1984 Act or by or under any other enactment.

- 57 For the avoidance of doubt any reference in this Order to a length of road or parking place shall be deemed to be a reference to more than one length of road or parking place where the context requires it.
- 58 Where the provisions of any Order made or having effect as if made under the 1984 Act which imposes any prohibition or restriction on waiting by vehicles or grants any exemption from such prohibition or restriction relating to a lengths of road designated as parking places in this Order the provisions of this Order shall prevail.


