Infrastructure Delivery Plan Update 2018

This note has been prepared to update the Ryedale Infrastructure Delivery Plan and the infrastructure requirements needed to support planned growth in Ryedale for the local plan period 2012-2027.

This update takes account of the infrastructure delivered to date. It also updates requirements to take account of the latest information from key infrastructure providers and identifies specific infrastructure needs required as a result of the specific combinations of development sites proposed in the Local Plan Sites Document.

The information will be used to prioritise the way in which money raised through the Community Infrastructure Levy will be spent; to secure developer contributions and to inform the capital programmes of infrastructure providers.
