2. DECLEATIONS OF INTEREST

2.1. No declarations of interest.

3. MINUTES OF LAST MEETING AND MATTERS ARISING

- **3.1.** Minutes of the meeting held on the 26th September agreed as a true record.
- **3.2.** LS provided a brief update on the Harbourside Public Realm designs. LS stated that the new designs will be shared with the board and key stakeholders when ready.

4. PANNET ART GALLERY – KERRY LEVITT

- **4.1.** KLV updated the board on Pannet Art Gallery expansion project on behalf ok Michael King as it was a project the board had considered.
- **4.2.** MP queried what the project entails. KLV confirms that it was to provide additional gallery space, external exhibition space, meeting room space and improve physical conditions for certain art collections.
- **4.3.** SP to help facilitate future conversation with his colleagues around funding options.
- **4.4.** LS states that the new Council have an interim cultural delivery plan, will look at inviting the relative colleagues.

5. WHITBY MARITIME TRAINING HUB - HELEN JACKSON

- **5.1.** HJ gave an update on the Whitby Maritime Training Hub (WMTH)
- **5.2.** AR clarified to the board issues that have been raised. Scarborough Borough Council have not asked for an extra 1 million pound for this project, the contractor is in place and that all options are being explored for the operator model for the building.
- **5.3.** LW queried why sourcing an operator for the WMTH was an issue. AR stated that there is significant work being carried out to address the issue and risk in taking on the WMTH. HJ supports this, there is a strong interest in this but the extra work will help mitigate risks for those who wish to tender.
- **5.4.** BH queried if there was any further risks to be aware of for the WMTH. HJ stated that that construction costs are also a risk. AR also stated that Planning is also a risk and the board need to promote the importance of the project.

5.5. JF queried how the board can keep up with the risk mitigations. AR confirmed that there is a monthly report that is being issued to the board that highlights all Whitby Towns Fund projects risks.

6. COMMUNICATIONS UPDATE – ANDY CARTER

- **6.1.** AC provided a communications update, covering Minister Dehanna Davison visit and the future communications plan for the Whitby Towns Fund Project.
- **6.2.** BH queried the plan for a pop up shop exhibition and shared information for potential units to use.
- **6.3.** PF asked when the videos for the projects will be ready and stated they can share on NYMNPA channels.
- **6.4.** BH queried how communications will look after Local Government Reorganisation for the Whitby Town Deal Board. AC stated he is unsure of how it will look but confirmed that it will have a dedicated communications plan.
- **6.5.** RDR queried where all the information can be found. AC stated that there is a Town Deal section on Scarborough Borough Council website.
- **6.6.** AR asked if there could be an F&Q section on the website. AC confirmed fast style communication is key.

- **7.4.** KLV provided a brief update on the Whitby Old Town Hall project. BH queried if there is any issues around the project. KLV states that stakeholder concerns have been addressed in the project. HJ reiterates the strength in community engagement.
