2. MINUTES OF LAST MEETING & MATTERS ARISING

- 2.1 Minutes of the meeting held on Friday 25th September 2020 agreed as a true record.
- 2.2 No matters arising.

3. PRESENTATION OF SUBMISSION DOCUMENT

- 3.1 GE thanked Aecom for pulling together and requested Board Members submit any proofing comments noticed via email or chat and use the meeting to raise key issues with the document.
- 3.2 JH presented the Whitby Town Investment Plan document and ran through each of the key sections;
 - Context
 - Strategy
 - Engagement & Delivery
- 3.3 The Board made a number of comments on the document. JH and the team at Aecom to address the following points:
 - Strengthen the section on housing need
 - Include overcrowding & the impact of narrow streets in respect of the covid-19 pandemic
 - Re-word the section that refers to the Government's Furlough scheme
 - Inclusion of Whitby's healthy high street & low crime rate in the strengths
 - Reference to the survival pool & firefighting provision needs reinserting under the Maritime Heritage centre
 - Ensure outputs & outcomes for each project are clearly identified and pulled out where known
- 3.4 Aecom will ensure a thorough read of the document will happen to pick up any typos before submission.

3.5 JH and the team to make amendments and recirculate to the Board before submission.

4. UPDATE ON FAST TRACK FUNDING

- 4.1 AR provided a quick update on the projects under the £500k accelerated funding received. Whitby Wild Eye & the 2nd phase of the Whitby Sculpture Trail are progressing well.
- 4.2 JF requested if the National Park Authority had a way the impact the Wild Eye project has on nature tourism could be measured. PF will put JF in touch with colleagues who can assist.
- 4.2 A planning application for the locations of the 2nd phase of the sculpture trail is being submitted. LW & MK requested if WTC and the arts community could have more engagement with respect to the Sculpture Trail and the locations of the sculptures. MJ will make contact with WTC and Helen Berry.
- 4.3 BM also requested to be involved in the conversations to ensure links between the sculpture trail, wild eye and Pannett Park art trail are picked up in the wider Masterplan for Whitby.
- 4.4 CH will also ensure the lead of the Whitby Wild Eye project has engaged with WTC.
- 4.5 Further engagement sessions are being arranged with WTC, NYCC and SBC for November with regards to the pilot pedestrianisation scheme of Whitby Swing Bridge.
