2. MINUTES OF LAST MEETING AND MATTERS ARISING

- 2.1 Minutes of the meeting held on Friday 22nd May agreed as a true record.
- 2.2. DK and SBC have received the further guidance document from Government that the Board have been awaiting. There are three cut off dates to submit a bid;
 - 31st July 2020
 - End of October 2020
 - End of January 2021

Towns must confirm within 4weeks of the release date of the guidance which cohort they will be submitting a bid.

The Board discussed the pros and cons of submitting an early application in July or sticking with the original date the Board were aiming for.

The Board agreed to stick with the original target for completion of the TIP by September 2020 and submit the bid in plenty of time for the October 2020 deadline.

- 2.3 The LEP received a late call from Government to submit a list of 'shovel ready' projects that can be achieved within the next 18months. Three projects for the Scarborough area were put forward;
 - Scarborough TEC
 - Scarborough Market Square
 - WiFi Digital Improvement programme

DK requested RG to lobby these projects for Scarborough.

3. WORKSTREAM PROJECT REVIEW / MAPPING & NEXT STEPS

- 3.1 BM delivered a presentation on the shortlisted projects received from each of the workstreams followed by a Strategic Overview by LSy.
- 3.2 RT provided further background information on the Newby & Scalby Hub project which was circulated prior to the meeting.
- 3.3 The Board held a discussion around the project ideas presented.
- 3.4 Aecom will now refine the project ideas based on comments received and map them out over the next 3 weeks. Feasibility and viability will be carried out on the key projects identified by the end of July.
- 3.5 Aecom will communicate progress to the Board via email ahead of the next scheduled meeting in July.
- 3.6 JG requested Aecom attend the next meeting of the Town Centre Team to present the project ideas that impact on the town centre.

4. COMMUNICATIONS UPDATE

- 4.1 EA has received lots of comments and feedback including the youth voice which have now been collated into a document. EA will circulate to the Board once Aecom have added the comments they have received directly.
