This Order is made by The North Yorkshire Council ("the Authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that in the interests of the owners of the land crossed by the Public Footpaths described in Paragraph 1 of this Order it is expedient that the line of the Paths should be diverted.

This Order is also made under Section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that The District Of Craven (outside The Yorkshire Dales National Park) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in Section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway shown or required to be shown in the map and statement.

Network Rail NW & Central Region, Manchester Square One, 4 Travis Street, Manchester M1 2NY has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the Path(s) into a fit condition for use by the public.

Giggleswick Parish Council have been consulted as required by Section 120(2) of the 1980 Act.

BY THIS ORDER:

- 1. The public right of way over the land situated at Close House Farm, Giggleswick and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up on the date on which the Authority certifies, in accordance with Section 119(3)(b) of the 1980 Act, that work to the new section of path, as described in Part 2 of the Schedule, has been completed to the reasonable satisfaction of the Authority and thereupon The District Of Craven (outside The Yorkshire Dales National Park) Definitive Map shall be modified by deleting from it that public right of way. Under no circumstances shall such certification be given before the date of confirmation of this Order.
- 2. There shall from the date of the above mentioned certification be the Public Footpath over the land situated at Close House Farm, Giggleswick described in Part 2 of the Schedule to this Order and shown by a bold broken line on the map contained in this Order and thereupon The District Of Craven (outside The Yorkshire Dales National Park) Definitive Map shall be modified by adding the Public Footpath to it.
- 2A. The District Of Craven (outside The Yorkshire Dales National Park) Definitive Statement shall be modified as described in Part 4 of the Schedule to this Order.
- 3. The following works shall be carried out by the applicant in relation to the highway described in Part 2 of the Schedule: A pedestrian gate to BS 5709 (2018) to be installed at Grid Reference 37993 46327 (Point E on the map) with minimum internal width of 1.6 metres and maximum of 3.7 metres.
- 4. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.







NOTICE OF CONFIRMATION OF A PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER

THE NORTH YORKSHIRE COUNCIL FOOTPATH 05.21/19 AND 05.21/61 CLOSE HOUSE FARM GIGGLESWICK DIVERSION ORDER 2023

The above Order made under Section 119 of the Highways Act 1980 and Section 53A(2) of the Wildlife and Countryside Act 1981 was confirmed on 8 August 2023.

The effect of the Order as confirmed is to divert the Public Footpath as follows: The Footpath will be diverted from the recorded line generally northwards across a level crossing, the A65 and a working farmyard, (SD 8004 6311 to SD 8007 6317 and SD 8008 6322 to SD 8007 6331); onto a new alignment north-westwards on grass across a field to join an existing Footpath which utilises an under-bridge and underpass (SD 8004 6311 to SD 7993 6327)

A copy of the order as confirmed and the Order Map have been placed and may be seen free of charge during normal office hours at Settle Community Library, Limestone View, Lower Greenfoot, Settle BD24 9RB (Tel. 01609 534535), North Yorkshire until Friday 29 September 2023. Copies of the Order and Map may be purchased from Countryside Access Service, North Yorkshire Council, County Hall, Northallerton, North Yorkshire, DL7 8AD (tel: 03001312131) at a cost of £2, or can be downloaded free from our website https://www.northyorks.gov.uk/pathnotices.

The Order comes into force 17 August 2023, but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980 as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under Paragraph 2 of Schedule 2 to the Act as applied by Paragraph 5 of Schedule 6 to the Act, within six weeks from 17 August 2023, make an application to the High Court.
