FARMS, COWLING DIVERSION ORDER 2021**

This Order is made by North Yorkshire County Council ("the Authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that in the interests of the owner(s) of the land crossed by the Public Footpaths described in Paragraph 1 of this Order it is expedient that the line of the Path(s) should be diverted.

Mr. Richard Ian Preston, Lower Windhill & High Stubbing, Cowling Hill, Cowling, BD22 0LJ has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the Path(s) into a fit condition for use by the public.

Craven District Council and Cowling Parish Council have been consulted as required by Section 120(2) of the 1980 Act.

**BY THIS ORDER:**

1. The public right of way over the land situated at Low Windhill And High Stubbing Farms, Cowling and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up on the date on which the Authority certifies, in accordance with Section 119(3)(b) of the 1980 Act, that work to the new section of path, as described in Part 2 of the Schedule, has been completed to the reasonable satisfaction of the Authority. Under no circumstances shall such certification be given before the date of confirmation of this Order.
2. There shall from the date of the above mentioned certification be the Public Footpaths over the land situated at Low Windhill And High Stubbing Farms, Cowling described in Part 2 of the Schedule to this Order and shown by a bold broken line on the map contained in this Order.
3. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

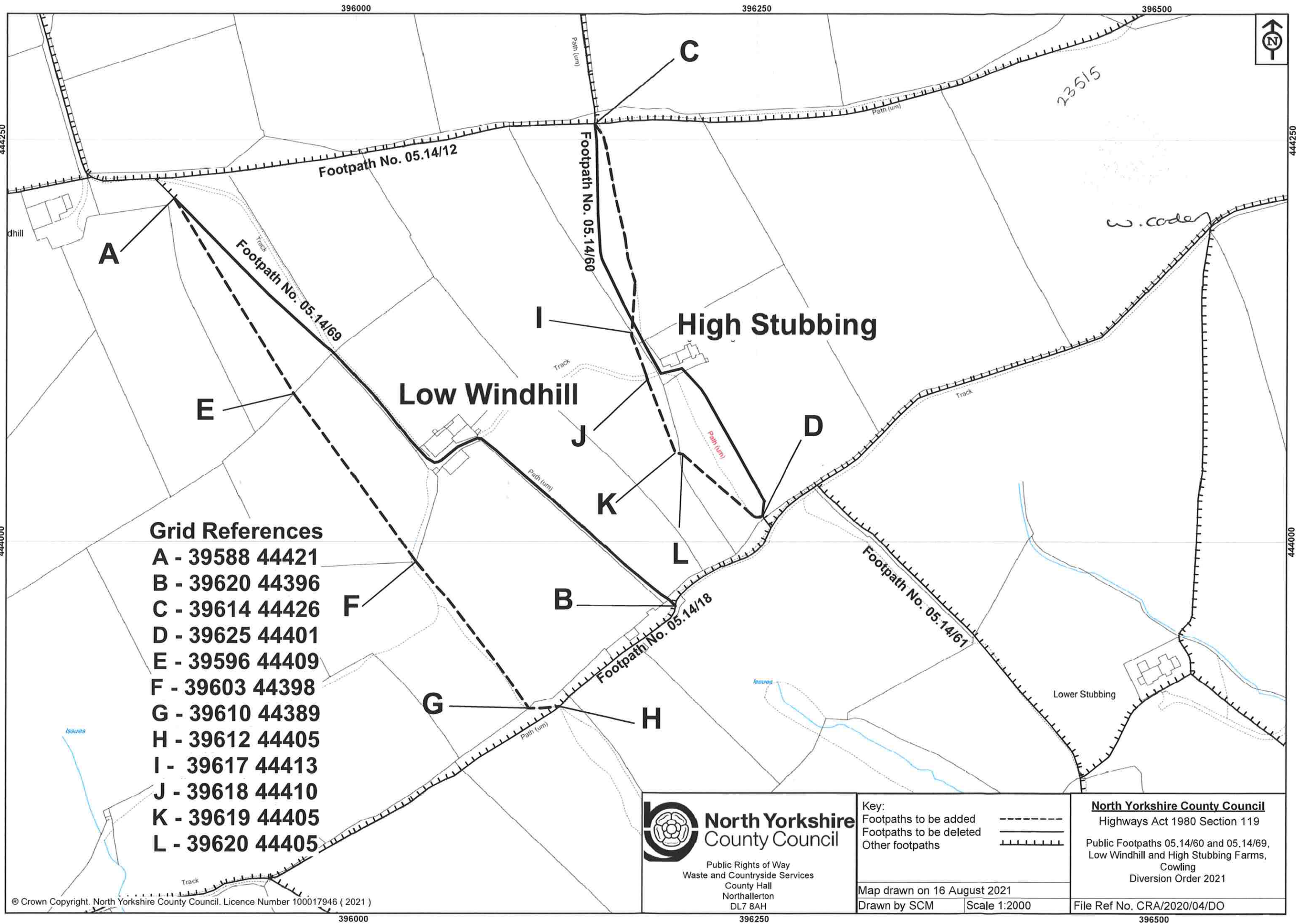

Total distance of 408 metres.	2 metres


