

**Application for the Temporary Closure  
of Footpath, Bridleway, Restricted Byway or Byway Open to all Traffic  
under the Road Traffic Regulation Act 1984.**

**Before filling out this application form please make sure you read the guidance notes.**

I/We the undersigned hereby request that the North Yorkshire Council make an order under Section 14 of the Road Traffic Regulation Act 1984 to temporarily close a Public Right of Way ('path') in accordance with the details set out below.

I enclose a copy of a plan indicating:

- 1) the section of the path to be closed in brown
- 2) the proposed temporary alternative route of the path in purple (where applicable)

*Please be aware if your works involve placing apparatus in the highway by a private contractor, a Section 50 license may be required. A Section 50 license covers any works to private drains and sewers as well as private gas, electricity, and water services.*

*Similarly, if a private contractor wants to excavate in the highway without placing apparatus, for example trial holes, a Section 171 license is required.*
