#### PUBLIC FOOTPATH 05.65/29 RAILWAY STATION HORTON IN RIBBLESDALE DIVERSION ORDER 2023

This Order is made by The North Yorkshire Council ("the Authority") under Section 257 of the Town and Country Planning Act 1990 ("the 1990 Act"), because it is satisfied that it is necessary to divert the Footpath to which this Order relates in order to enable development to be carried out in accordance with planning consent under Prior Approval (Reference NY/2022/0009/PAA), granted for Permitted Development under Schedule 2, Part 18, Class A of the Town and Country Planning (General Permitted Development) (England) Order 2015; namely the construction of a new footbridge, lift shafts and access, steps and infrastructure at the site; Horton in Ribblesdale Railway Station, Cragg Hill Road.

This Order is also made under Section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that The Former West Riding Of Yorkshire Area 1 (Dales) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in Section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway shown or required to be shown in the map and statement.

Network Rail, 1 Eversholt Street, London, NW1 2DN has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the Path(s) into a fit condition for use by the public.

#### BY THIS ORDER:

- 1. The footpaths over the land shown by a bold black solid line on the attached map and described in Part 1 of the Schedule to this Order shall be diverted, and the The Former West Riding Of Yorkshire Area 1 (Dales) Definitive Map and Statement shall be modified as provided below.
- 2. There shall be created to the reasonable satisfaction of The North Yorkshire Council an alternative highway for use as a replacement for the said footpaths as provided in Part 2 of the Schedule and shown by a bold black broken line on the attached map.
- 3. The diversion of the Footpath shall have effect on the date on which The North Yorkshire Council certificates that the terms of Article 2 above have been complied with, and upon the occurrence of that diversion the Former West Riding Of Yorkshire Area 1 (Dales) Definitive Map shall be modified by deleting from it the path or way referred to in paragraph 1 of this Order and the path or way referred to in paragraph 2 of this Order shall be added to it, and the Definitive Statement shall be modified as described in Part 4 of the Schedule.
- 4. The following works shall be carried out in relation to the highway described in Part 2 of the Schedule:

(1). Construct footbridge, ramp(s), access gap(s), and steps with associated railings, signage and other safety provisions, as specified in Part 3 of the Schedule; to the agreed drawings and Planning Conditions.

(2). Subject to the statutory powers exercisable by the Council or other Authority as Highway Authority, the Owner shall maintain the structures and furniture specified in Part 3 of the Schedule below and their associated infrastructure, commensurate with their use.

- 5. Network Rail, 1 Eversholt Street, London, NW1 2DN is hereby required to carry out and pay for the cost of carrying out the said works.
- 6. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

7. Where immediately before the date on which the footpaths are diverted there is apparatus under, in, on, over along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.




