

Notice of Making of a Public Path Diversion Order Highways Act 1980 The North Yorkshire Council Footpath No 25.54/28/1, Land at Westfields, Kirkbymoorside Diversion Order 2023.

The above Order, made on 6 November 2023, under Section 119 of the Highways Act 1980 will divert the public footpath described below.

Path no. 25.54/28/1, between SE 6884 8649 and SE 6905 8665 via SE 6888 8657, will be diverted onto a new route from SE 6884 8649 via SE 6885 8649, SE 6883 8653, SE 6888 8657, SE 6889 8658, SE 6895 8660, SE 6896 8661, SE 6896 8659, SE 6903 8662, SE 6902 8663 to SE 6905 8665. Path width will be recorded as 1.9 metres.

A copy of the Order and the Order map have been placed and may be seen free of charge during normal office hours at Kirkbymoorside Library until 13 December 2023. Any representations about or objections to the Order may be sent in writing to Matthew Lishman, Local Plans team, North Yorkshire Council, Ryedale House, Old Malton Road, Malton, YO17 7HH not later than 13 December 2023. Please state the grounds on which they are made. Please note that objections/representations cannot be treated as confidential and may come into the public domain. Copies of any objections or representations received may be disclosed to interested parties, including the Planning Inspectorate where the case is referred to it for determination. If no such representations or objections are duly made, or if any so made are withdrawn, North Yorkshire Council may confirm the Order as an unopposed Order. If the Order is sent to the Secretary of State for the Environment for confirmation, any representations and objections which have not been withdrawn will be sent with the Order.

DIVERSION ORDER 2023

This Order is made by The North Yorkshire Council ("the Authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that in the interests of the public and the owner(s) of the land crossed by the Public Footpath described in Paragraph 1 of this Order it is expedient that the line of the Path(s) should be diverted.

Countryside Partnerships (Yorkshire) c/o Countryside Properties (UK) Ltd, Countryside House, The Drive, Brentwood, Essex CM13 3AT has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the Path(s) into a fit condition for use by the public.

Kirkbymoorside Parish Council have been consulted as required by Section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public right of way over the land situated at Westfields, Kirkbymoorside and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up on the date on which the Authority certifies, in accordance with Section 119(3)(b) of the 1980 Act, that work to the new section of path, as described in Part 2 of the Schedule, has been completed to the reasonable satisfaction of the Authority. Under no circumstances shall such certification be given before the date of confirmation of this Order.
2. There shall from the date of the above-mentioned certification be the Public Footpath over the land situated at Westfields, Kirkbymoorside described in Part 2 of the Schedule to this Order and shown by a bold broken line on the map contained in this Order.

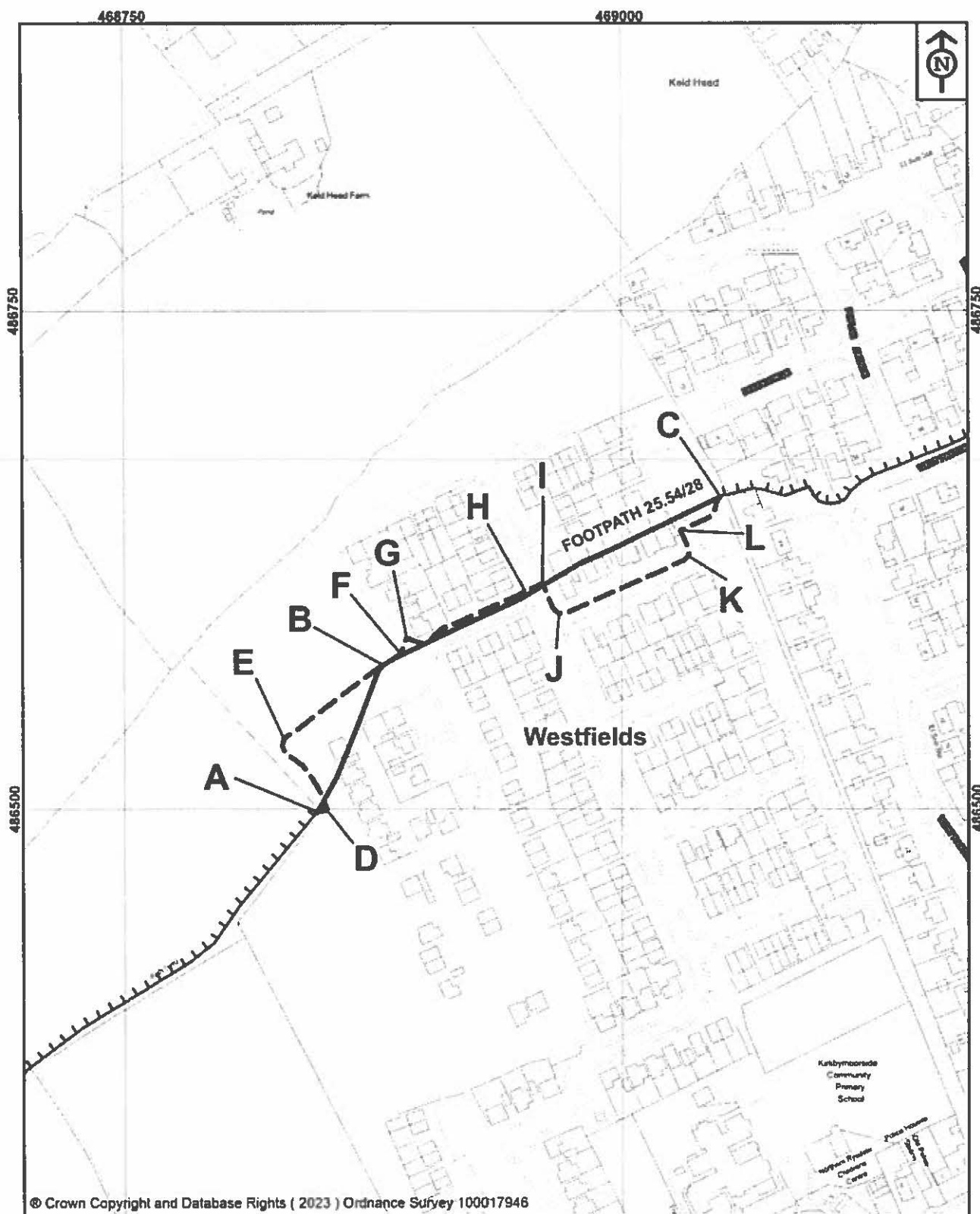

<u>Section of Footpath as shown on the attached map</u>	<u>Position</u>	<u>Width</u>
Public Footpath 25.54/28 as marked with a bold dashed line (A-D-E-F-G-H-I-J-K-L-C) on the attached plan	Commences at Grid Reference 46884_48649 (Point A) and runs east along a hoggin surfaced path for approximately 5 metres to Grid Reference 46885_48649 (Point D), then generally north-north-west along the same path for approximately 43 metres to Grid Reference 46883_48653 (Point E), then north-east along the same path for approximately 74 metres to Grid Reference 46888_48657 (Point F), then north-east across a tarmac roadway for approximately 8 metres to Grid Reference 46889_48658 (Point G), then generally east-north-east along a tarmac footway running along the north-side of an estate road for approximately 66 metres to a road junction at Grid Reference 46895_48660 (Point H), continuing east-north-east across the junction for approximately 9 metres to the tarmac footway at Grid Reference 46896_48661 (Point I), then south-south-east along the footway for approximately 17 metres to Grid Reference 46896_48659 (Point J), then east-north-east along the same footway for approximately 71 metres to Grid Reference 46903_48662 (Point K), then north-north-west along the same footway for approximately 14 metres to Grid Reference 46902_48663 (Point L), then generally north-east for approximately 28 metres along a tarmac footpath to the continuation of the path at Grid Reference 46905_48665 (Point C).	1.9 metres
