This Order is made by North Yorkshire County Council ("the Authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that in the interests of the owner(s) of the land crossed by the Public Bridleway described in Paragraph 1 of this Order it is expedient that the line of the Way(s) should be diverted.

Mr. Edward Spier, Murky Hill Farm Offices, Cow Lane, Middleton Tyas, DL10 6RW has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the Way(s) into a fit condition for use by the public.

Richmondshire District Council and Middleton Tyas Parish Council have been consulted as required by Section 120(2) of the 1980 Act.

BY THIS ORDER:

- The public right of way over the land situated at Brook House Farm, Middleton Tyas and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up on the date on which the Authority certifies, in accordance with Section 119(3)(b) of the 1980 Act, that work to the new section of path, as described in Part 2 of the Schedule, has been completed to the reasonable satisfaction of the Authority. Under no circumstances shall such certification be given before the date of confirmation of this Order.
- 2. There shall from the date of the above mentioned certification be the Public Bridleway over the land situated at Brook House Farm, Middleton Tyas described in Part 2 of the Schedule to this Order and shown by a bold broken line on the map contained in this Order.
- 3. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

The foregoing order is hereby confirmed subject to the red ink modifications thereon

Marked by a bold dashed line and shown as C-D-E-F- G-H on the attached plan.	Commences at the unclassified road at a bridle gate at Grid Reference 42388 50677 (Point C) then runs in a north-easterly direction for approximately 150 metres to a bridle gate at Grid Reference 42403 50680 (Point D), then runs in a south-easterly direction for approximately 46 metres to an access track at Grid Reference 42406 50678 (Point E), then runs along the access track in a south-south-east direction for approximately 100 metres to Grid Reference 42408 50667 (Point F) and continues for approximately 53 metres into the field at Grid Reference 42408 50662 (Point G), then runs in a south-westerly direction for approximately 125 metres, then turns and runs in a south-south- easterly direction for approximately 74 metres to a gap at Grid Reference 42405 50646 (Point H) and then continuing for approximately 12 metres to its junction with the original route of bridleway 20.46/24 at Grid Reference 42405 50645 (Point B).	4 metres



Notice of Confirmation of a Public Path Diversion Order Highways Act 1980 North Yorkshire Council Public Bridleway No. 20.46/24, Brook House Farm, Middleton Tyas Diversion Order 2021. The above-named Order, made under Section 119 of the Highways Act 1980, was confirmed on 26 September 2023. The effect of the Order as confirmed is to divert the Public Bridleway described below.

Public Bridleway 20.46/24 from NZ 2394 0657 to NZ 2405 0645, will be diverted onto a new route running from NZ 2388 0677 in a north-easterly direction to NZ 2403 0680, then to NZ 2406 0678, NZ 2408 0667, NZ 2408 0662, NZ 2405 0646 and NZ 2405 0645.

A copy of the order as confirmed and the Order Map may be seen free of charge during normal office hours at Richmond Community Library, North Yorkshire until 22 December 2023. The Order comes into force on the date on which the Authority certifies, in accordance with Section 119(3)(b) of the 1980 Act, that work to the new section of path, described in Part 2 of the Schedule, has been completed, but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980 as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under Paragraph 2 of Schedule 2 to the Act as applied by Paragraph 5 of Schedule 6 to the Act, within six weeks from 10 November 2023, make an application to the High Court.
