IN THE MATTER OF AN APPLICATION TO SURRENDER A REGISTERED RIGHT OF COMMON AND APPLICATION FOR REMOVAL OF THE RIGHT FROM THE REGISTER OF COMMON LAND UNDER SECTION 13 OF THE COMMONS ACT 2006

CLAPHAM COMMON (CL209) – RIGHT ENTRIES 14, 15, 19 and 21, BURN MOOR (CL211) – RIGHT ENTRIES 18, 19, 23 and 25, BURN MOOR (CLAPHAM PORTION) (CL270) – RIGHT ENTRIES 7, 8, 12 and 14 AND CLAPHAM COMMON & CLAPHAM MOOR (PART) (CL304) – RIGHT ENTRIES 2, 3, 7 and 9.

An application has been made to North Yorkshire Council by F & K (no.19921993) under Section 13 of the Commons Act 2006. The application sought to surrender registered rights of common and remove them from the register of common land at right entry numbers 14, 15, 19 and 21 of common land unit CL209, right entry numbers 18, 19, 23 and 25 of common land unit CL211, right entry numbers 7, 8, 12 and 14 of common land unit CL270 and right entry numbers 2, 3, 7 and 9 of common land unit CL304.

The Commons Registration Authority is satisfied that the application complies with the requirements of Section 13 of the Commons Act 2006 and Paragraph 7, Schedule 4 of the Commons Registration (England) Regulations 2014 for right entry numbers 14, 15, 19 and 21 of common land unit CL209, right entry numbers 18, 19, 23 and 25 of common land unit CL211, right entry numbers 7, 8, 12 and 14 of common land unit CL270 and right entry numbers 2, 3, 7 and 9 of common land unit CL304 but not for right entry number 22 of common land unit CL209, right entry number 26 for common land unit CL211, right entry number 15 for common land unit CL270 and right entry number 10 for common land unit CL304.

The Commons Registration Authority has therefore amended right entry numbers 14, 15, 19 and 21, right entry numbers 18, 19, 23 and 25, right entry numbers 7, 8, 12 and 14 and right entry numbers 2, 3, 7 and 9 in accordance with the Commons Registration (England) Regulations 2014 to show that the grazing rights have been extinguished and removed from the registers in relation to the common land unit CL209, CL211, CL270 and CL304. Right entry number 22 of common land unit CL209, right entry number 26 for common land unit CL211, right entry number 15 for common land unit CL270 and right entry number 10 for common land unit CL304 remain unamended.
