The authority has consulted with every local authority whose area includes the land to which the Order relates. The North Yorkshire Council hereby order that:-

- 1. For the purpose of this Order the relevant date is 10 January 2024.
- 2. The District of Richmondshire (outside the Yorkshire Dales National Park) Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
- 3. This Order shall take effect on the date it is confirmed and may be cited as the Restricted Byway No.20 64/7 Stanwick St John Modification Order 2024.


