Proposed savings to be achieved within C&YPS. More effective delivery of Family time sessions using our embedded practice model "Family Seeing" By identifying a strong family network around the child enabling Family time to be supported and delivered by family members who love the child reducing the number of family time activity being delivered by professionals. Going forward only those children at significant risk of harm will require Family time to be delivered by a professional who is not known to the child.

Section 2. Why is this being proposed? What are the aims? What does the authority hope to achieve by it? (e.g. to save money, meet increased demand, do things in a better way.)

Reduction of Children's and Families Support Worker's roles from 65 fte to 50 fte To achieve proposed budget saving by the reduction of 15 fte posts.

Over the last 12 months detailed analysis has taken place reviewing the delivery of family time, a time and motion study and a review of working practice. It is evident that due the service can achieve these efficiencies through the current holding of vacancies as practitioners leave and reviewing the working patterns of future roles employing a greater number of part time posts to cover afternoon and early evening activities which is when the greater number of sessions are required

Alongside this all workers across C&F service have received significant training in family seeing enabling practitioners to be confident in identifying a safe family network who can provide support and care around the child which will lead to the reduction in the amount of supervised family time.

Section 3. What will change? What will be different for customers and/or staff?

We will continue to meet the requirement of supervised family time through efficiencies following he review however moving to the family seeing model will ensure a great number of children will be supported by people within their network who are known and already love and care for the child. This trauma informed approach will improve the outcomes of children in care providing them with a secure family network of support.

Savings will be achieved through the holding of vacancies offering progression opportunities within the service which will have no impact on staff. Future recruitment of posts will consider increasing the number of part time posts to accommodate the needs of the children in care and their families.

Families of children in care have been involved in a research project to develop and embed the family seeing model.

A 12-month review of family time activities was undertaken between April 2023 and April 2024 to ascertain the number of workers required to enable continuous service delivery
