On 27 February 2025 the Secretary of State for Environment, Food and Rural Affairs confirmed the above-named Order.

The effect of the confirmed Order is to modify the Definitive Map by upgrading to Byway Open to All Traffic the bridleway from GR SE 0665 7714 to GR SE 0652 7721, and upgrading to Restricted Byway the footpath/bridleways from GR SE 0652 7721 to GR SE 1363 7717.


#### **MODIFICATION ORDER 2020**


