(NO 58) ORDER 2025

NOTICE is hereby given that The North Yorkshire Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1(1), 2(1) to (3), 4(2), 32(1) and 35(1) of the Road Traffic Regulation Act 1984 ("the 1984 Act") and Part IV of Schedule 9 to the 1984 Act and under the Traffic Management Act 2004 ("the 2004 Act"), the effect of which will be to revoke those Orders set out in schedule 3 below and introducing the restriction specified in Schedule 1 and 2 below;
