THE NORTH YORKSHIRE COUNCIL

(40 MPH SPEED LIMIT) (VARIOUS ROADS, BURNT YATES) ORDER 2025

The North Yorkshire Council in exercise of their powers under Sections 84(1) and (2) of the Road Traffic Regulation Act 1984 ("the 1984 Act") and Part IV of Schedule 9 to the 1984 Act and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby order as follows:-

- 1. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on any length of road specified in Schedule 1 hereto.
- 2. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any Order or regulations made or having effect as if made under the Act or by or under any other enactment.
- 3. This Order shall come into operation on **\$** and may be cited as "The North Yorkshire Council (40 mph Speed Limit) (Various Roads, Burnt Yates) Order 2025".
- 4. The speed limits on various lengths of roads in North Yorkshire County Council (Various Roads, Burnt Yates) (20mph, 30mph and 50mph Speed Limits) Order 2019 are revoked as described in Column 2 of Schedule 2 below.
