If the Order is submitted to the Secretary of State for the Environment, in whole or in part, any representations or objections which have been duly made and not withdrawn will be sent with it.

This Order is made by The North Yorkshire Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the authority that the Definitive Map and Statement for the District of Richmondshire (Outside the Yorkshire Dales National Park) and the Western Part of the County of the former North Riding of Yorkshire Definitive Map and Statement require modification in consequence of the occurrence of an event specified in 53(3)(c) (ii) of the Act, namely, the discovery by the Authority of evidence which (when considered with all other relevant evidence available to them) shows that a highway shown in the map and statement as a highway of a particular description ought to be there shown as a highway of a different description.

The authority has consulted with every local authority whose area includes the land to which the Order relates. The North Yorkshire Council hereby order that:-

- 1. For the purpose of this Order the relevant date is date of 9th June 2025.
- 2. The Definitive Map and Statement for the District of Richmondshire (Outside the Yorkshire Dales National Park) and the Western Part of the County of the former North Riding of Yorkshire Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
- 3. This Order shall take effect on the date it is confirmed and may be cited as the Restricted Byway 20.75/58 Reeth, Fremington and Healaugh & 20.42/9 Marrick Fremington Edge Modification Order 2025.
