ORDER 2025 NO 355  
Road Traffic Regulation Act 1984 – Section 14(1) (as amended)

North Yorkshire Council has made this Order to prohibit any pedestrian, cyclist or person riding or leading a horse from using the Public Bridleways 30.36/201 (SE88859908 – SE91919798), 30.36/600, 30.36/663, 30.36/665 (NZ91610368 – SE88859908) in the parish of Fylingdales, in the parish of Goathland & Public Footpaths 30.36/203 (NZ89980173 - SE93039948), 30.36/213, 30.36/562 (NZ90160322 – NZ89870161), 30.36/658 in the parish of Fylingdales, 30.50/023, 30.50/029 (NZ88910103 – NZ89860159) in the Parish of Sneaton, for a temporary period of up to six months (subject to access to premises) between 30<sup>th</sup> September 2025 and 8<sup>th</sup> March 2026, as the land currently poses a danger to public safety due to the exposing of unexploded ordinance following a wildfire on site. This Order follows Emergency Notice No 149.

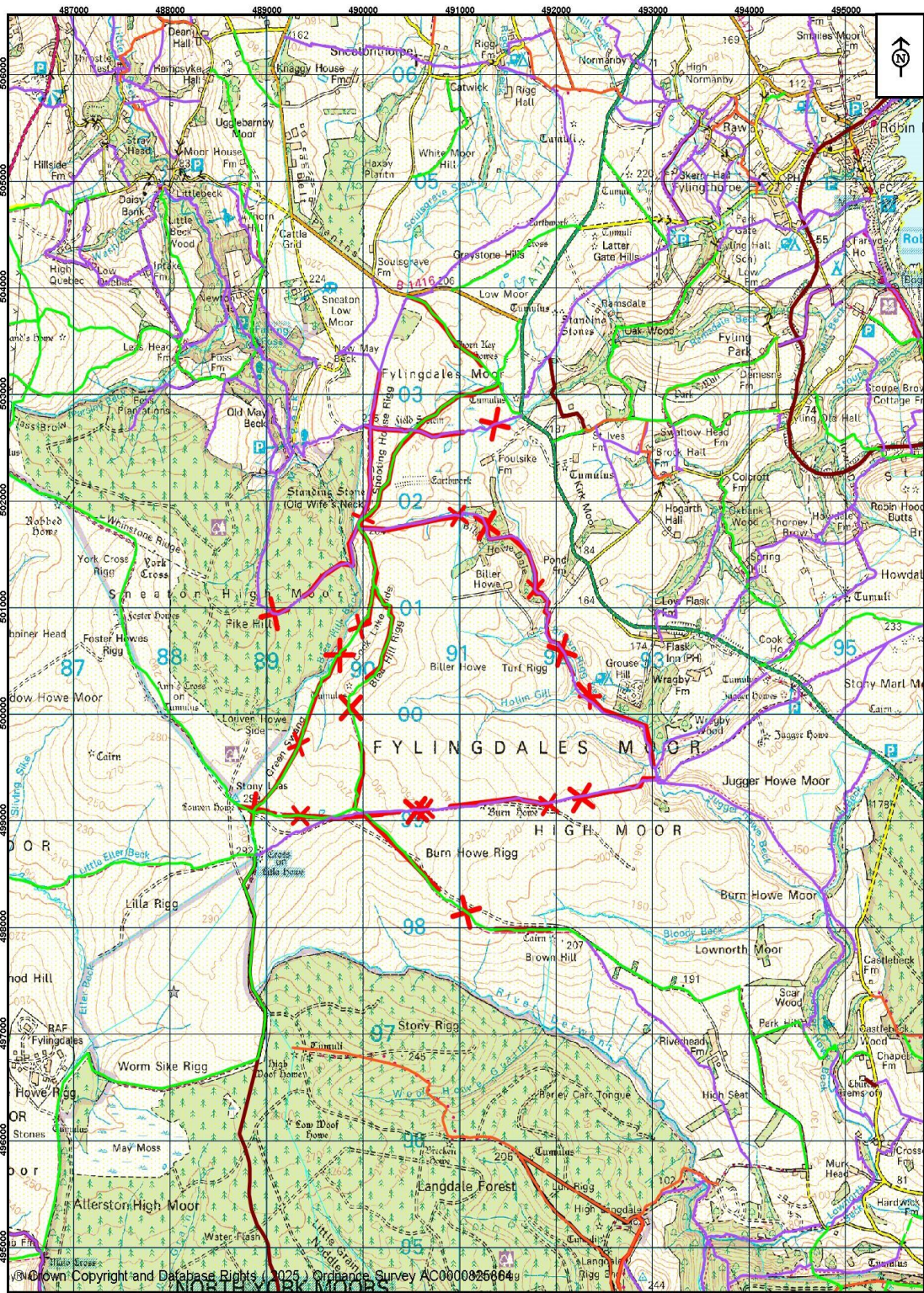
The closure period will apply as indicated by the placing of traffic signs
