Notice of Confirmation of a Public Path Diversion Order & Definitive Map & Statement Modification Order, Highways Act 1980 & Wildlife & Countryside Act 1981. The North Yorkshire Council Public Footpath No. 35.7/5, The Retreat, (Formerly The King's Arms), Beal, Diversion Order 2025. The above Order, made under Section 119 of the Highways Act 1980 & Section 53A(2) of the Wildlife & Countryside Act 1981, was confirmed on 12.9.25. The effect of the Order as confirmed is to divert the Public Footpath described as: Public Footpath No. 35.7/5 from GR SE5328 2543 to GR SE5328 2549, will be diverted onto a new route from GR SE5328 2543 to GR SE5330 2549. A copy of the Order as confirmed & the Order Map may be seen free of charge during normal office hours at Selby Library, 52 Micklegate, Selby, North Yorkshire until 13.11.25. Copies of the Order and Map may be purchased from Countryside Access Services, North Yorkshire Council, County Hall, Northallerton, North Yorkshire, DL7 8AD (tel: 0300 1312131) at a cost of £2, or can be downloaded free from our website www.northyorks.gov.uk/pathnotices.

The Order comes into force on 9.1.26 (120 days from the date of confirmation), but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980 as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under Paragraph 2 of Schedule 2 to the Act as applied by Paragraph 5 of Schedule 6 to the Act, within six weeks from 2.10.25, make an application to the High Court. This Order is made by The North Yorkshire Council ("the Authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that in the interests of the owner of the land crossed by the footpath described in Paragraph 1 of this Order it is expedient that the line of the path should be diverted.

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the Authority that The Former West Riding of Yorkshire Area No.3 Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway shown or required to be shown in the Map and Statement.

Mr Campey of Unit 5, Kettlestring Lane, York has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

Beal Parish Council have been consulted as required by Section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public right of way over the land situated at The Retreat (Formerly The King's Arms), Beal as described in Part 1 of the Schedule to this Order and shown by a bold continuous line on the map contained in this Order shall be stopped up from the date on which the Authority certifies, in accordance with Section 119(3)(b) of the 1980 Act, that work to the new section of path, described in Part 2 of the Schedule, has been completed, and thereupon The Former West Riding of Yorkshire Area No.3 Definitive Map shall be modified by deleting from it that public right of way.
2. There shall at the end of 120 days from the date of confirmation of this Order be a public footpath over the land situated at The Retreat (Formerly The King's Arms), Beal as described in Part 2 of the Schedule to this Order and shown by a bold broken line on the map contained in this Order, and thereupon The Former West Riding of Yorkshire Area No.3 Definitive Map shall be modified by adding that path to it.
3. The Former West Riding of Yorkshire Area No.3 Definitive Statement shall be modified as described in Part 3 of the Schedule to this Order.
4. The following works shall be carried out in relation to the highway described in Part 2 of the Schedule: removal of stumps, roots and border edging to provide a good firm level surface for the new path, topped with 100mm MoT Type-1 road stone or similar, to blend with existing tarmac surface; create 2 metre wide exit for the new path to join Marsh Lane.

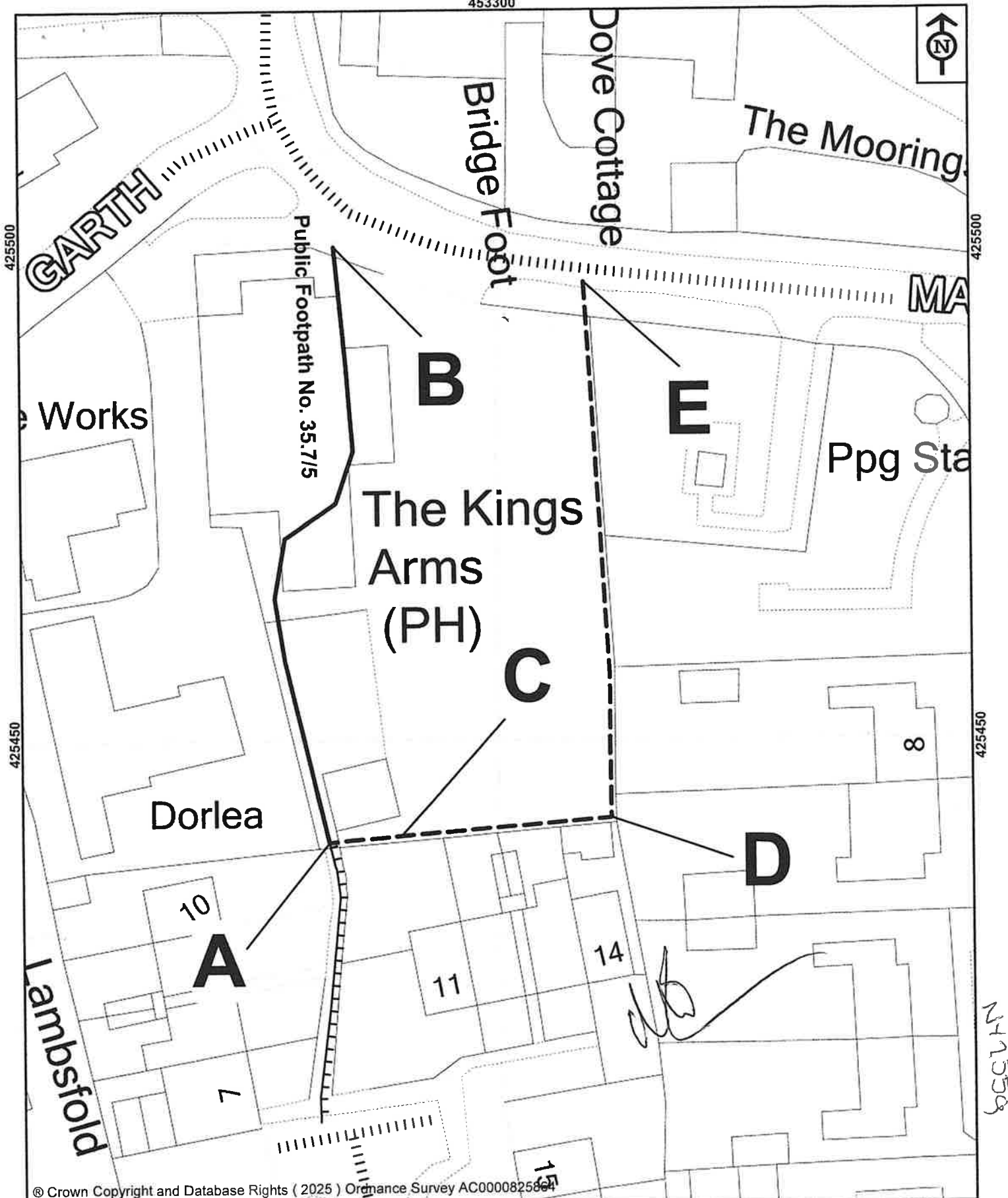

From Grid Reference 45328 42543 (Point A) at the south-western corner of The Retreat's curtilage, and runs generally east between garage and property boundary for approximately 7 metres to Grid Reference 45329 42544 (Point C), and then continues east along the property boundary for approximately 20 metres to Grid Reference 45331 42544 (Point D) and then runs north following the boundary for approximately 50 metres to join Marsh Lane at Grid Reference 45330 42549 (Point E). Total distance of approximately 77 metres on a stone and tarmac surface.	Points A – C: varying between 1.1 & 1.4 metres Points C – E: 2 metres

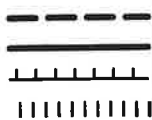
