(20 MPH & 30 MPH & 40 MPH SPEED LIMITS) (VARIOUS ROADS, EGTON AND EGTON BRIDGE) ORDER 2025

NOTICE is hereby given that The North Yorkshire Council proposes to make an Order under Sections 84(1) and (2) of the Road Traffic Regulation Act 1984 and Part IV of Schedule 9 to the 1984 Act, the effect of which will be to prohibit any motor vehicle from travelling at a speed in excess of 20 miles per hour on any length of road specified in Schedule 1 below; in excess of 30 miles per hour on any length of road specified in Schedule 2 and in excess of 40 miles per hour on any length of road specified in Schedule 3.

Schedule 1 Speed limit 20

<u>Column 1</u> <u>Item</u>	<u>Column 2</u> <u>Road</u>	<u>Column 3</u> <u>Length</u>
1.	C82 (High Street to Egton Cliff)	From a point 130 metres north of Egton Cliff in a northerly direction for 269 metres.
2.	C82 (Broom House Lane to Egton Cliff)	From its junction with Broom House Lane in a north-easterly direction for 290 metres.

Schedule 2 Speed limit 30

<u>Column 1</u> <u>Item</u>	<u>Column 2</u> <u>Road</u>	<u>Column 3</u> <u>Length</u>
1.	Delves Lane	From its junction with the C82 in a westerly direction for 164 metres.
2.	C82 (Broom House Lane to Key Green)	From its junction with Broom House Lane in a south-westerly direction for 411 metres.
3.	Broom House Lane	From its junction with the C82 in a westerly direction for 489 metres.
4.	C84	From its junction with the C82 in a northerly direction for 138 metres.
5.	Browns Wood Cottages	For its entirety.
6.	Egton Lane	From its junction with the C82 in a westerly direction for 65 metres.
7.	C82 (Egton Lane to Guisborough Road)	From its junction with Egton Lane in a north-easterly direction for 348 metres.
8.	High Street	For its entirety.
9.	Cross Farm	For its entirety.
10.	C56	From its junction with High Street in an easterly direction for 232 metres.
11.	C82 (High Street to Egton Cliff)	From its junction with C56 in a southerly direction for 342 metres.

Speed limit 40

1.	C82 (High Street to Egton Cliff)	From Egton Cliff in a northerly direction for 130 metres.
2.	Egton Cliff	For its entirety.
