NOTICE is hereby given that The North Yorkshire Council proposes to make an Order under Sections 1(1), 2(1) to (3), 4(2), 32(1) and 35(1) of the Road Traffic Regulation Act 1984 ("the 1984 Act") and Part IV of Schedule 9 to the 1984 Act and under the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby proposes to make the following Order:-

1	Princess Mount Knaresborough	West	From a starting point of 10 metres north of the junction with Princess Avenue for a distance of 11.5 metres in a south west direction to the boundary line of property number 22
2	Princess Mount Knaresborough	East	From a starting point of 10 metres north of the junction with Princess Avenue for a distance of 12 metres in a south east direction to the boundary line of property number 20
3	Princess Grove Knaresborough	West	From a starting point of 10 metres north of the junction with Princess Avenue for a distance of 11 metres in a south west direction to the boundary line of property number 10
4	Princess Grove Knaresborough	East	From a starting point of 10 metres north of the junction with Princess Avenue for a distance of 14.5 metres in a south west direction to the boundary line of property number 8
5	Princess Avenue Knaresborough	South	From a point 5.5 metres west of the boundary line between properties 23 and 25 for 9.4 metres in an easterly direction.
