

**THE NORTH YORKSHIRE COUNCIL
NOTICE OF VARIATION OF CHARGES AT OFF-STREET PARKING PLACES
CRAVEN
ROAD TRAFFIC REGULATION ACT 1984 – SECTION 35C**

The North Yorkshire Council hereby gives NOTICE in exercise of its powers under Sections 35(1), 35(3) and 35C of the Road Traffic Regulation Act 1984 and Regulation 25 of the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 that it is to vary the current parking charges for pay and display off-street parking places in Schedule I to the Craven District Council (Off Street Parking Places) Consolidation Order 2013. The Variation is to introduce revised charges for pay and display as set out below:-
