

THE NORTH YORKSHIRE COUNCIL

(20MPH AND 40MPH SPEED LIMIT)
(VARIOUS ROADS, LITTLETHORPE)
ORDER 2026

The North Yorkshire Council in exercise of their powers under Sections 84(1) and (2) of the Road Traffic Regulation Act 1984 ("the 1984 Act") and Part IV of Schedule 9 to the 1984 Act and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby order as follows:-

1. No person shall drive any motor vehicle at a speed exceeding 20 miles per hour on any length of road specified in Schedule 1 hereto.
2. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on any length of road specified in Schedule 2 hereto.
3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any Order or regulations made or having effect as if made under the Act or by or under any other enactment.
4. This Order shall come into force on **TBC** and may be cited as "The North Yorkshire Council (20mph and 40 mph Speed Limit) (Various Roads, Littlethorpe) Order 2026".
5. 'The order specified in Schedule 3 column 1 "North Yorkshire County Council (Restricted Roads) (Various Roads, Littlethorpe) Order 2001" is hereby revoked to the extents shown in Column 2 of said schedule.'

SCHEDULE 1

VARIOUS ROADS IN THE PARISH OF LITTLETHORPE

20 MPH SPEED LIMIT

<u>Column 1</u> <u>Item</u>	<u>Column 2</u> <u>Road</u>	<u>Column 3</u> <u>Length</u>
1.	Littlethorpe Lane	From a point 65 metres south east of its junction with the A61 Ripon By-Pass in a south easterly direction to its junction with Pottery Lane
2.	Littlethorpe Road	From its junction with Pottery Lane in a easterly then north westerly direction for a distance of approximately 420 metres
3.	Mankin Lane	From its junction with Littlethorpe Lane in a south westerly direction for a distance of 67 metres.
4.	Pottery Lane	From its junction with Littlethorpe Lane in a generally southerly direction for a distance of approximately 360 metres
5.	Washington Close	For its entirety.

40 MPH SPEED LIMIT

1.	Littlethorpe Road	From a point approximately 420 metres north east of its junction with Pottery Lane in a north westerly direction for a distance of approximately 312 metres
