READVERTISEMENT

NOTICE is hereby given that The North Yorkshire Council proposes to make an Order under Sections 1(1), 2(1) to (3), 4(2), 32(1) and 35(1) of the Road Traffic Regulation Act 1984 and Part IV of Schedule 9 to the 1984 Act and under the Traffic Management Act 2004, the effect of which will be to amend “North Yorkshire County Council (Harrogate, Knaresborough, Pannal and Burn Bridge) (Parking and Waiting) (No. 16) Order 2013” by introducing the restrictions specified in the Schedules below:-

2	Ainsty Road (U1/3/50), Harrogate	South east	From a point 17.5 metres south west of its junction with Gascoigne Crescent to a point 6 metres north east of its junction with Gascoigne Crescent.
3	Gascoigne Crescent (U295/3/50), Harrogate	Both	From its junction with Ainsty Road to a point 13 metres south east of its junction with Ainsty Road.
4	Hambleton Road (U326/3/50), Harrogate	West/ South west	From its intersection point with the north west kerb line of Ainsty Road to a point 25 metres north and north west of its intersection point with the projected boundary line of 26/ 28 Hambleton Road.
