WARLEY WISE FARM, WARLEY WISE LANE, COWLING DIVERSION ORDER 2026

This order is made by The North Yorkshire Council under section 257 of the Town and Country Planning Act 1990 because it is satisfied that it is necessary to divert the footpath to which this order relates in order to enable development to be carried out in accordance with planning permission granted under Part 3 of the Town and Country Planning Act 1990, namely:

Planning Permission granted by The North Yorkshire Council on 7th August 2025 for the dismantling of existing portal framed building including extensions. Conversion and extension of traditional agricultural building, change of use class to provide a wedding/events venue and associated external works and landscape works. The diversion is to move the footpath off the access road and car park.

Cowling Parish Council have been consulted.

BY THIS ORDER:

1. The Footpath over the land shown by a bold black continuous line on the attached map and described in Part 1 of the Schedule to this Order ("the Schedule") shall be diverted as provided below.
2. There shall be created to the reasonable satisfaction of The North Yorkshire Council an alternative highway for use as a replacement for the said Footpath as provided in Part 2 of the Schedule and shown by a bold black dashed line on the attached map.
3. The diversion of the Footpath shall have effect on the date which The North Yorkshire Council certifies that the terms of Article 2 above have been complied with. Under no circumstances shall such certification be given before the date of confirmation of this Order.
4. The Owner shall carry out the following Works, in order to give effect to Article 2 above:

At Point D on the attached map, create a gap in the southern boundary wall to BS 5709:2018 with a minimum width of 1100mm and install a pedestrian gate in the northern boundary wall to BS 5709:2018 with a minimum width of 1100 mm clear of hinges and latch.

Install at Point E on the attached map, a pedestrian gate to BS 5709:2018 with a minimum width of 1100 mm clear of hinges and latch.
5. The Owner is hereby required to pay the cost of carrying out the Works, in accordance with the planning conditions and as detailed in the Schedule Part 3 and Article 4 above.
6. Where immediately before the date on which the Footpath is diverted there is apparatus under, in on, over, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.

7. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule to this Order.

Public Footpath 05.14/79 Marked by a bold continuous black line and shown as B – D on the attached plan	26 metres	1.2 metres	<u>05.14/79</u> Commencing at Grid Reference SD 9428 4354 (Point B) and proceeds in a generally eastern direction to Grid Reference SD 9430 4354 (Point D)

Marked by a bold broken black line and shown as A – D – E on the attached plan.	146 metres	3 metres	<u>05.14/78</u> Commencing at Grid Reference SD 9428 4349 (Point A) and proceeds generally in a north north easterly direction for approximately 59 metres on a grass surface across fields to a gap in the southern boundary wall at Grid Reference SD 9430 4354 (Point D), then from a gate in the northern boundary wall at Grid Reference SD 9430 4354 (Point D) proceeds in a generally north north westerly direction for approximately 87 metres on a grass surface to a gate in the wall on Warley Wise Lane at Grid Reference SD 9427 4362 (Point E).

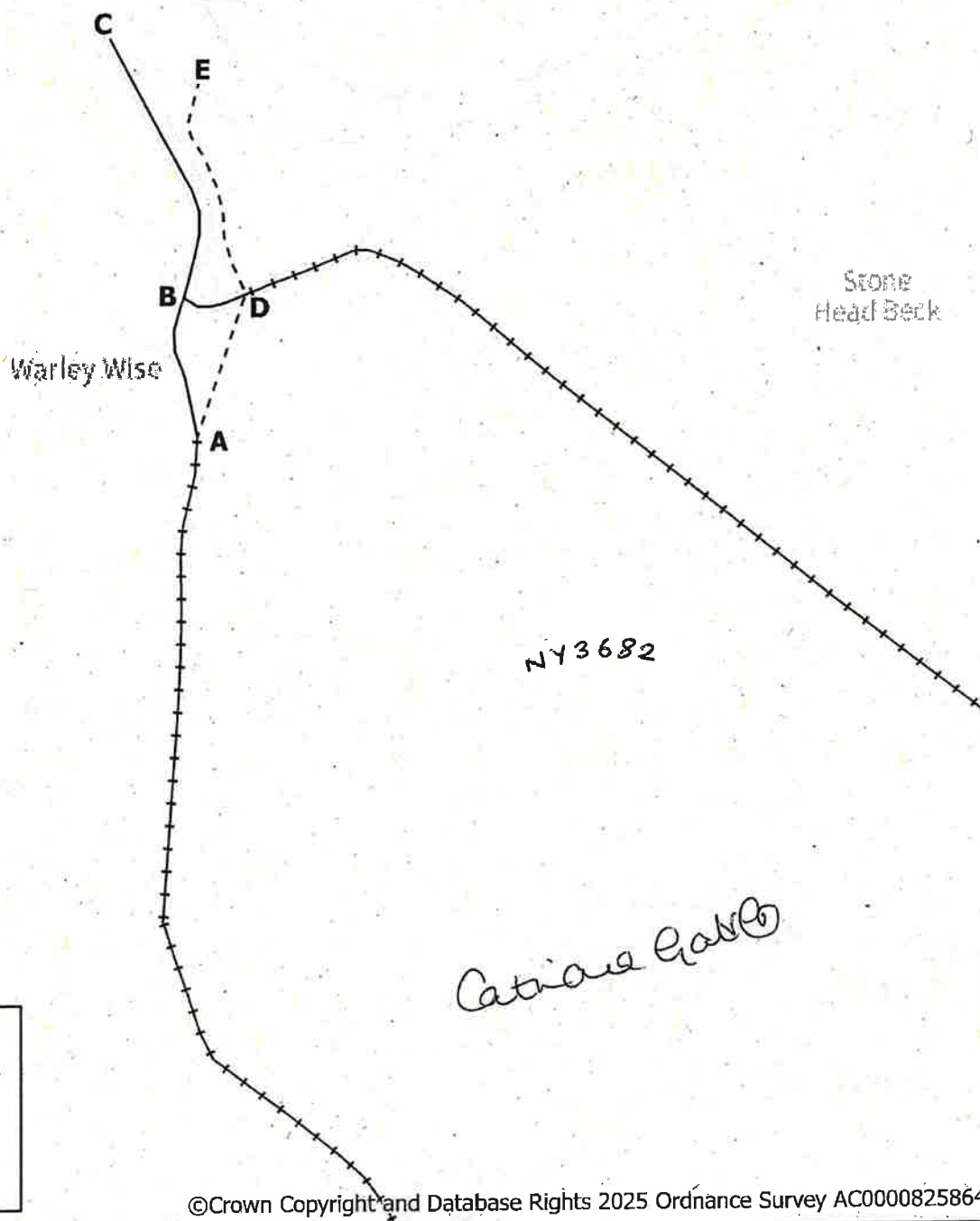
