## North Yorkshire County Council Approved Provider List for Non- Regulated Services

### North Yorkshire County Council Approved Provider List for Non-Regulated Services

The Council's Approved Provider List for Non-Regulated Services has now been published on YORtender. The Approved Provider List will be in place from 1 March 2017 for a maximum period of five years until 28 February 2022.

In order to ensure consistency of service provision and enable existing providers of Non-Regulated Services to be able to continue to receive referrals for new packages of support from the Council while their application was being processed and approved, a grace period was implemented. During this period the Council has been able to continue to source new packages of support from existing providers.

**This grace period comes to an end on 30 April 2017.**

To date, only a small number of applications to join the Approved Provider List for Non-Regulated have been submitted on YORtender. **If your organisation was on the previous list and has not submitted an application by 30 April 2017, the Council will be unable to source new packages of support after this date until such time as an application has been both received and approved.**

For the purposes of this Approved Provider List, the term 'Non-Regulated Services' refers to a range of support services that are not regulated by the Care Quality Commission (CQC) but may be accessed by children, young adults, adults and older people who are ordinarily resident in North Yorkshire and may wish to receive community based support, which may include support in their own home but not personal care.

Examples of Non-Regulated Services include (but are not limited to):

- Collective Care Settings i.e. day centre, day service, lunch club etc which is usually delivered within an agreed specific venue for a number of individuals;
- Collective Care Settings for employment training i.e. employment services, training etc delivered to a number of individuals which could be delivered in a specific venue or out in the community depending on the provider;
- Non Collective Care Settings i.e. any day time activities and services which are not venue based and are delivered on an individual basis rather than a group;
- Non Collective Care Home Based Settings i.e. any day time activities and services which are delivered in a home setting and are on an individual basis rather than a group, such as a sitting scheme; and
- Practical Support Services i.e. any practical support that does not include care to the individual such as home improvements, telecare, shopping, cleaning and pet services.

New and existing providers of Non-Regulated Services who wish to apply to join the Approved Provider List but have not previously registered an interest on YORtender can access the application documents by doing so now (please see attached guidance). Providers who have previously registered an interest in the opportunity should be able to access the application documents by logging into YORtender, clicking on "My Activities", selecting "North Yorkshire County Council" pressing the green "Update" button and selecting "Non-Regulated Services Approved Provider List".

Applications will be processed as they are received and new packages of support may be sourced once these applications have been approved.
