in the Parish of Newby and Scalby in the District of Scarborough.

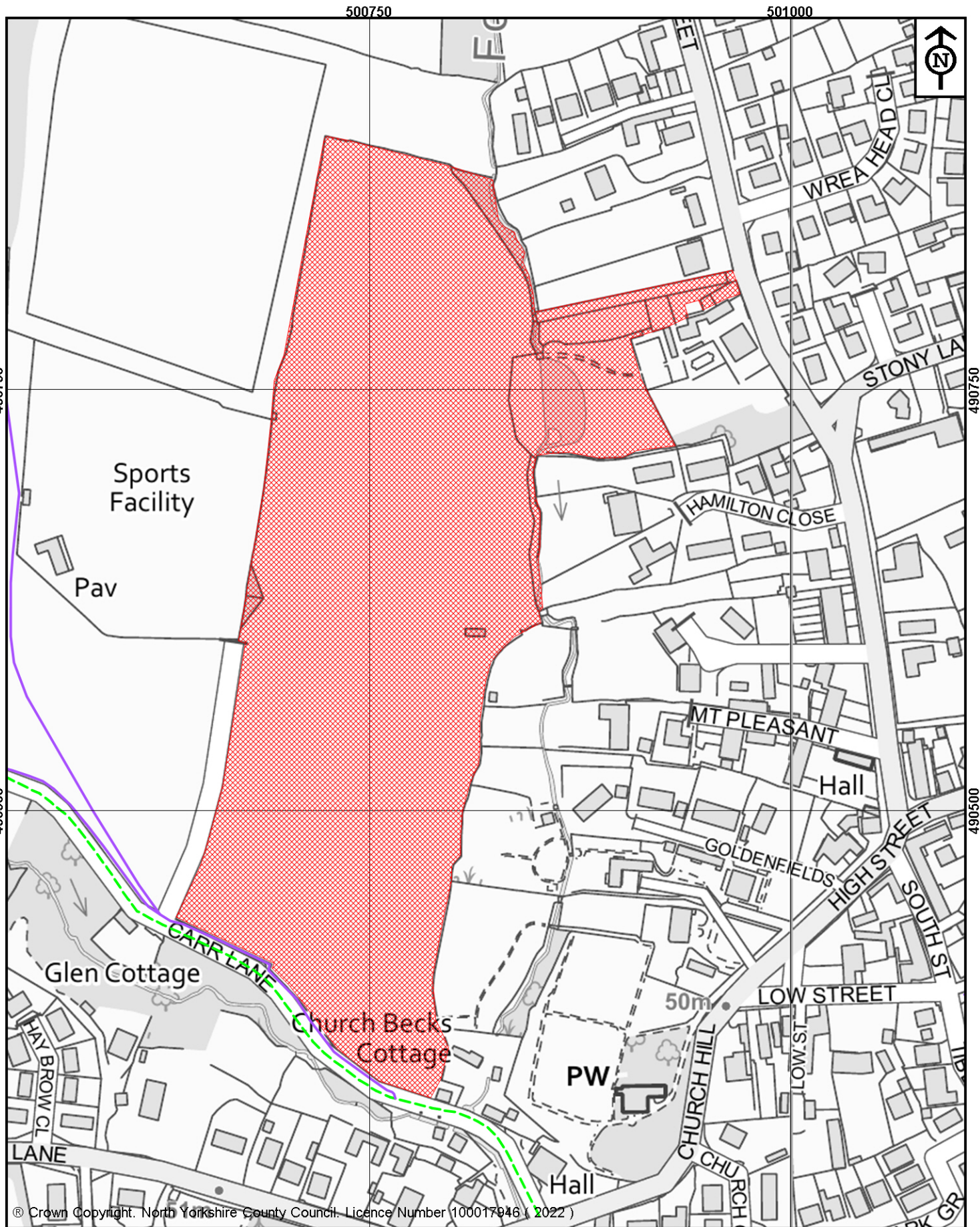
