On 22 August 2017, North Yorkshire County Council confirmed the above Order made under Section 118 of the Highways Act 1980 and Section 53A(2) of the Wildlife and Countryside Act 1981.

The effect of the Order as confirmed is to extinguish the public footpath described below and modify The District of Hambleton (Outside the North York Moors National Park) Definitive Map and Statement accordingly.

Path No 10.47/7 running between the A1 at GR SE 3016 8749 and the village of Londonderry at GR SE 3031 8759 will be extinguished.

A copy of the order as confirmed and the Order Map have been placed and may be seen free of charge during normal office hours at Northallerton Library, North Yorkshire until 13 October 2017. Copies of the Order and Map may be purchased from Waste & Countryside Services, North Yorkshire County Council, County Hall, Northallerton, North Yorkshire, DL7 8AD (tel: 01609 532512) at a cost of £2.00, or can be downloaded free from our website [www.northyorks.gov.uk/pathnotices](http://www.northyorks.gov.uk/pathnotices).

The Order comes into force on the date of confirmation, but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980 as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under Paragraph 2 of Schedule 2 to the Act as applied by Paragraph 5 of Schedule 6 to the Act, within six weeks from 01 September 2017, make an application to the High Court.

This Order is made by North Yorkshire County Council ("the Authority") under Section 118 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that the footpath described in paragraph 1 below is not needed for public use.

This order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that The District of Hambleton (Outside the North York Moors National Park) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the stopping up (as authorised by this order) of a highway hitherto shown or required to be shown in the map and Statement.

Hambleton District Council and Exelby, Leeming and Newton Parish Council have been consulted as required by Section 120(2) of the 1980 Act.

**BY THIS ORDER**

1. The public right of way over the land situate at Manor House, Londonderry shown by a continuous bold line on the map attached to this Order and described in Part 1 of the Schedule to this Order shall be extinguished on confirmation of this Order, and thereupon The District of Hambleton (Outside the North York Moors National Park) Definitive Map shall be modified by deleting from it that public right of way, and the Definitive Statement shall be modified as described in part 2 of the Schedule to this Order.

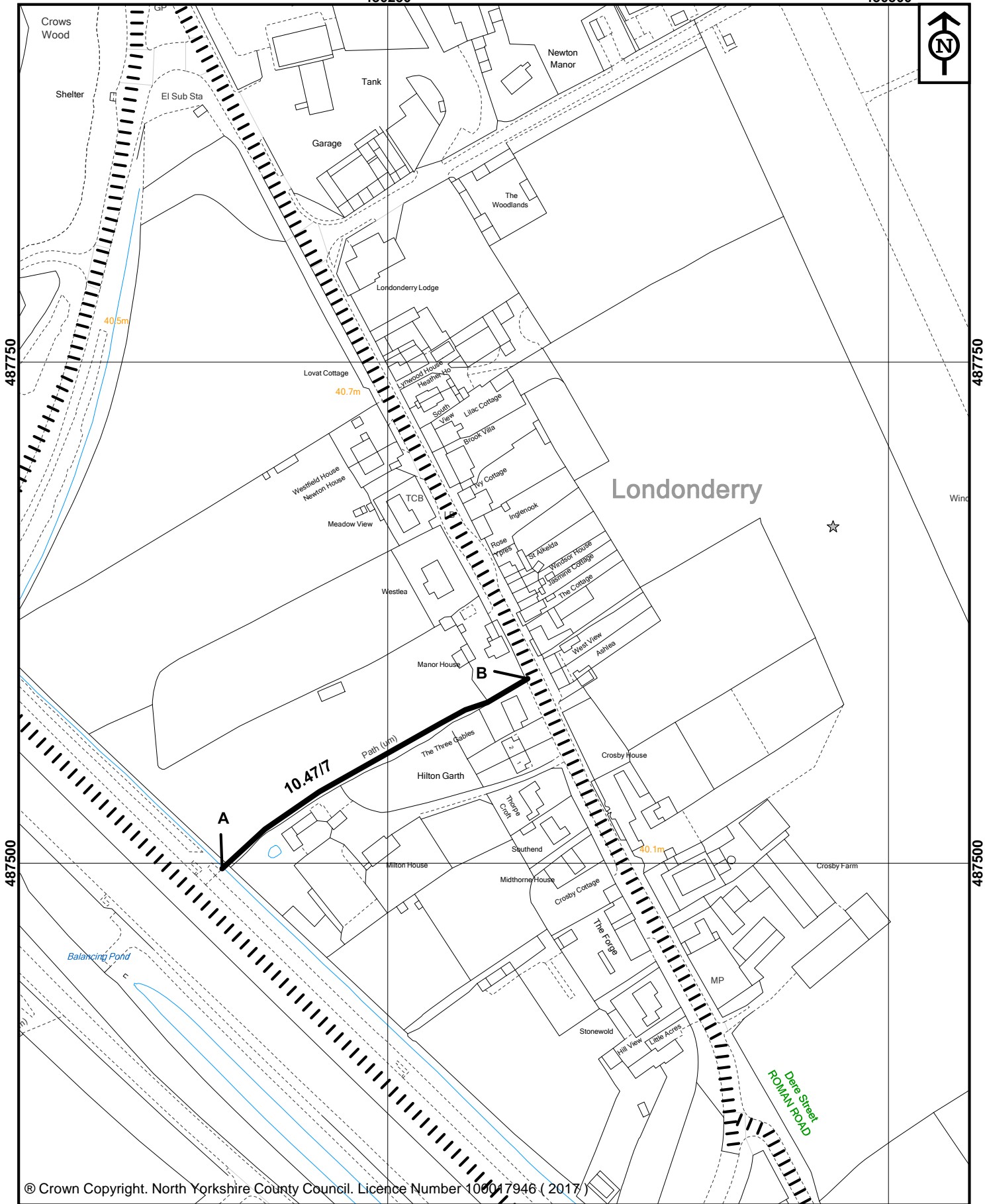
