(PROHIBITION OF MOTOR VEHICLES) (U1858/9, KIRBY BANK)
ORDER 2018

North Yorkshire County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1(1), 2(1), 2(2) and 3(2) of the Road Traffic Regulation Act 1984 ("the 1984 Act") and Part IV of Schedule 9 to the 1984 Act and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby make the following Order:-

1. In this Order "motor vehicle" has the meaning assigned to it by Section 136(1) of the 1984 Act.
2. Save as provided in article 3 of this Order no person shall cause or permit any motor vehicle to proceed along the U1858/9, Kirby Bank, between the gateway at the southern end of Hill Road at Toft Hill and the gateway immediately south of the junction with the Cleveland Way National Trail.
3. Nothing in article 2 of this Order shall render it unlawful for any motor vehicle to proceed along the road therein specified if the motor vehicle is being used:-
 - (a) for fire brigade, police, or ambulance purposes;
 - (b)
 - (i) in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of that road or any part thereof or the laying erection alteration or repair in that road or in land accessible only from that road of any sewer or of any main pipe, cable or apparatus for the supply of gas water or electricity or of any electronic communications network or electronic communications service as defined in Schedule 3A and Section 32 of the Communications Act 2003;
 - (ii) in the service of a local authority or water authority in pursuance of their statutory powers and duties;
 - (iii) in connection with the management of private land or the use of private premises whose access leads directly onto that road;

and cannot conveniently be used for such purpose in any other road.

4. The Council are satisfied that for preventing damage to the road it is requisite that Section 3(1)(b) of the 1984 Act should not apply in relation to this Order.
5. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any Order or regulations made or having effect as if made under the Act or by or under any other enactment.
6. This Order shall come into operation on 19 November 2018 and may be cited as "North Yorkshire County Council (Prohibition of Motor Vehicles) (U1858/9, Kirby Bank) Order 2018".


