(NO 41) ORDER 2021

NOTICE is hereby given that North Yorkshire County Council proposes to make an Order under Sections 1(1), 2(1) to (3), 4(2), 32(1) and 35(1) of the Road Traffic Regulation Act 1984 and Part IV of Schedule 9 to the 1984 Act and under the Traffic Management Act 2004, the effect of which will be to amend "North Yorkshire County Council (Prohibition of Waiting and Loading and Provision of Parking) (Harrogate, Knaresborough, Pannal and Burnbridge) (Amendment No 16) Order 2013" by introducing the restrictions specified in the Schedules below:-

Amend Item 2902 to read:

Item 2902, Iles Lane, North west side, from a point 34 metres north east of the junction of Windsor Lane to a point 44 metres north east of the junction of Windsor Lane; Item 2902(a), Iles Lane, North west side, from a point 53 metres north east of the junction of Windsor Lane to a point 58 metres north east of the junction of Windsor Lane;

Amend item 2903 to read:

Item 2903, Iles Lane, North west side, from a point 19 metres north east of the junction with Windsor Lane to a point 24 metres north east of the junction with Windsor Lane.

EXISTING PARKING BAY MONDAY TO SATURDAY 8AM TO 6PM – 30 MINUTES NO RETURN WITHIN 2 HOURS

SCHEDULE 15

Revoke Item 1 and replace with:

Item 1, Iles Lane, North west side from a point 24 metres north east of the junction with Windsor Lane to a point 34 metres north east of the junction with Windsor Lane; Item 1a, Iles Lane, North west side from a point 44 metres north east of the junction with Windsor Lane to a point 53 metres south west of the junction with York Place.
