(PROHIBITION OF HEAVY COMMERCIAL VEHICLES) (ROADS IN THE TOWN OF MALTON)
EXPERIMENTAL ORDER 2021

NOTICE is hereby given that on 26 January 2021 North Yorkshire County Council made an Order under Sections 9 and 10 of the Road Traffic Regulation Act 1984 and Part IV of Schedule 9 to the 1984 Act, the effect of which is to prohibit heavy commercial vehicles, for an experimental period of eighteen months.

The County Council will be considering, in due course, whether the provisions of the Order should be continued in force indefinitely. Within a period of six months from the coming into force of the Order, or if the Order is subsequently varied or modified, from the coming into operation of that variation or modification (whichever is the later), any person may object to the making of an Order for the purposes of such indefinite continuation.

Any person wishing to object to the indefinite continuation of the Order must state the grounds for their objection, in writing, addressed to **Area 4 Kirby Misperton Highways Office, Beansheaf Industrial Park, Totts Road, Kirby Misperton, Malton, North Yorkshire YO17 6BG** or by to email **area4.kirbymisperton@northyorks.gov.uk** or via the website link above by **4 August 2021**.

If any person wishes to question the validity of the above Experimental Order or of any provision contained in it, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act, or of any instrument made under it, has not been complied with in relation to the Order, they may, within six weeks of 26 January 2021 make application to the High Court for that purpose
