ORDER 2020

NOTICE is hereby given that North Yorkshire County Council proposes to make an Order under Sections 1(1), 2(1) to (3), 4(2), 32(1) and 35(1) of the Road Traffic Regulation Act 1984 and Part IV of Schedule 9 to the 1984 Act and under the Traffic Management Act 2004, the effect of which will be to amend "North Yorkshire County Council (Harrogate, Knaresborough, Pannal and Burn Bridge) (Parking and Waiting) " by introducing the restrictions specified in the Schedules below:-

SCHEDULE 1

WAITING PROHIBITED AT ALL TIMES WITH EXEMPTIONS

Birstwith Road, Harrogate, West side, from a point 14.5 metres south of its junction with Lynton Gardens to a point 23.5 metres south of its junction with Lynton Gardens; Lynton Gardens, Harrogate, South side, from its junction with Birstwith Road to a point 4.9 metres west of its junction with Birstwith Road.

SCHEDULE 2 – PART I

DISC PARKING ZONES WITH EXEMPTIONS FOR PARKING PERMITS

Zone H5, Birstwith Road, Harrogate, the west side from a point 4 metres south of its junction with Lynton Gardens to a point 14.5 metres south of its junction with Lynton Gardens. Days of operation - Mon – Sat, 9.00am - 6.00pm, Maximum permitted stay time - 2 hours; Limit on return of vehicle to parking place in zone - that day; Zone H5, Lynton Gardens, Harrogate, the south side from a point 4.9 metres west of its junction with Birstwith Road to a point 27 metres west of its junction with Birstwith Road. Days of operation - Mon – Sat, 9.00am - 6.00pm, Maximum permitted stay time - 2 hours; Limit on return of vehicle to parking place in zone - that day.
