ORDER 2007 (AMENDMENT NO 69) ORDER 2020

NOTICE is hereby given that North Yorkshire County Council proposes to make an Order under Sections 1(1), 2(1) to (3), 4(2), 32(1) and 35(1) of the Road Traffic Regulation Act 1984 and Part IV of Schedule 9 to the 1984 Act and under the Traffic Management Act 2004, the effect of which will be to amend "North Yorkshire County Council (Prohibition of Waiting and Loading and Provision of Parking) (District of Scarborough) Order 2007" by introducing the restrictions specified in the Schedules below:-

SCHEDULE 1

LOCATION OF PROPOSED PROHIBITION OF WAITING AND LOADING AND PROVISION OF PARKING

Belle Vue Terrace, Whitby, East side, from a point 4 metres south of its junction with Crescent Place to a point 5 metres north of its junction with Albert Place, Restriction – Limited Waiting 3 hours, no return within 2 hours, with permit exemptions, 9.00am to 7.00pm, Disc Zone W.

SCHEDULE 2

EXISTING RESTRICTIONS AFFECTED BY PROPOSED RESTRICTIONS IN SCHEDULE 1

Belle Vue Terrace, Whitby East side, from a point 4 metres south of its junction with Crescent Place to a point 28 metres south of its junction with Crescent Place, Restriction - Limited Waiting 3 hours, no return within 2 hours, with permit exemptions, 9:00am to 7:00pm, Disc Zone W;

Belle Vue Terrace, Whitby, East side from a point 47 metres south of its junction with Crescent Place to a point 5 metres north of its junction with Albert Place, Restriction - Limited Waiting 3 hours, no return within 2 hours, with permit exemptions, 9:00am to 7:00pm, Disc Zone W
