

**NORTH YORKSHIRE COUNTY COUNCIL**  
**(PROHIBITION OF WAITING AND LOADING AND PROVISION OF PARKING)**  
**(DISTRICT OF SCARBOROUGH)**  
**(AMENDMENT NO 69 ) ORDER 2021**

**NOTICE** is hereby given that on 15 01 2021 North Yorkshire County Council made an Order under Sections 1(1), 2(1) to (3), 4(2), 32(1) and 35(1) of the Road Traffic Regulation Act 1984 and Part IV of Schedule 9 to the 1984 Act and under the Traffic Management Act 2004, the effect of which is to amend "North Yorkshire County Council (Prohibition of Waiting and Loading and Provision of Parking) (District of Scarborough) Consolidation Order 2013" by introducing the restrictions specified in the Schedules below:-

**SCHEDULE 1**

**LOCATION OF PROPOSED ORDER**

Belle Vue Terrace, Whitby, East side from a point 4 metres south of its junction with Crescent Place to a point 5 metres north of its junction with Albert Place; Restriction – Limited waiting 3 hours, no return within 2 hours, with permit exemptions, 9:00am to 7:00pm, Disc Zone W.

**SCHEDULE 2**

**EXISTING RESTRICTIONS AFFECTED BY PROPOSED RESTRICTIONS IN SCHEDULE 1**

Belle Vue Terrace, Whitby, East side, from a point 4 metres south of its junction with Crescent Place to a point 28 metres south of its junction with Crescent Place; Restriction – Limited waiting 3 hours, no return within 2 hours, with permit exemptions, 9:00am to 7:00pm, Disc Zone W;

Belle Vue Terrace, Whitby, East side from a point 47 metres south of its junction with Crescent Place to a point 5 metres north of its junction with Albert Place; Restrictions – Limited waiting 3 hours, no return within 2 hours, with permit exemptions, 9:00am to 7:00pm, Disc Zone W.

If you wish to question the validity of the above Order or of any provision contained in it, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act, or of any Instrument made under it, has not been complied with in relation to the Order, you may, within six weeks of 15 01 2021 make application to the High Court for the purpose.
