(PROHIBITION OF WAITING AND LOADING AND PROVISION OF PARKING)
(WHEATCROFT AVENUE)
(CONSOLIDATION ORDER 2011) (AMENDMENT NO 101) ORDER 2020

NOTICE is hereby given that North Yorkshire County Council proposes to make an Order under Sections 1(1), 2(1) to (3), 4(2), 32(1) and 35(1) and 45 to 49 of the Road Traffic Regulation Act 1984 and Part IV of Schedule 9 to the 1984 Act and under the Traffic Management Act 2004, the effect of which will be to amend "North Yorkshire County Council (Prohibition of Waiting and Loading and Provision of Parking) (District of SCARBOROUGH) Consolidation Order 2011" by introducing the restrictions specified in the Schedules below:-

Schedule 1

Revocations

Wheatcroft Avenue, Scarborough

Both sides, from its junction with Holbeck Hill to its north eastern cul de sac end.

Schedule 2

No Waiting At Any Time

Wheatcroft Avenue, Scarborough

North West side:-

from its junction with Holbeck Hill to a point 15 metres to the north east of Holbeck Hill;
from a point 43 metres north east of its junction with Holbeck Hill to a point 55 metres to the north east of Holbeck Hill;
from a point 75 metres north east of its junction with Holbeck Hill to a point 85 metres to the north east of Holbeck Hill;
from a point 110 metres north east of its junction with Holbeck Hill to its north eastern cul de sac end.

South East side:-

from its junction with Holbeck Hill to a point 15 metres to the north east of Holbeck Hill;
from a point 26 metres north east of its junction with Holbeck Hill to a point 38 metres to the north east of Holbeck Hill;
from a point 49 metres north east of its junction with Holbeck Hill to a point 68 metres to the north east of Holbeck Hill;
from a point 120 metres north east of its junction with Holbeck Hill to its north eastern cul de sac end.
