(AMENDMENT NO 20) ORDER 2020

NOTICE is hereby given that North Yorkshire County Council proposes to make an Order under Sections 1(1), 2(1) to (3), 4(2), 32(1) and 35(1) of the Road Traffic Regulation Act 1984 and Part IV of Schedule 9 to the 1984 Act and under the Traffic Management Act 2004, the effect of which will be to amend “North Yorkshire County Council (Prohibition of Waiting and Loading and Provision of Parking) (District of RICHMONDSHIRE) Consolidation Order 2013” by introducing the restrictions specified in the schedule hereto:-

PROPOSED WAITING RESTRICTIONS - VARIOUS ROADS, CATTERICK GARRISON

Road	Side	From	To	Nature of Restriction
Linton Rise	North	Its junction with Byng Road	A point 21 metres south west of its junction with Byng Road	No Waiting At Any Time
Albermarle Drive	North	Its junction with Byng Road	A point 12 metres north east of its junction with Byng Road	No Waiting At Any Time
Kingfisher Drive	Both	Its junction with Byng Road	A point 8 metres south west of its junction with Byng Road	No Waiting At Any Time
Byng Road	West	Its junction with Linton Rise	A point 29 metres north of its junction with the north side of Kingfisher Drive	No Waiting At Any Time
Byng Road	East	Its junction with Albermarle Drive	A point 29 metres north of its junction with the north side of Kingfisher Drive (measured along the western kerbline)	No Waiting At Any Time
