(PROHIBITION OF WAITING AND LOADING AND PROVISION OF PARKING)
(DISTRICT OF RICHMONDSHIRE)
(AMENDMENT NO 19) ORDER

NOTICE is hereby given that on 30 October 2020 North Yorkshire County Council made an Order under Sections 1(1), 2(1) to (3), 4(2), 32(1) and 35(1) of the Road Traffic Regulation Act 1984 and Part IV of Schedule 9 to the 1984 Act and under the Traffic Management Act 2004, the effect of which is to amend "North Yorkshire County Council (Prohibition of Waiting and Loading and Provision of Parking) (District of RICHMONDSHIRE) Consolidation Order 2013" by introducing the restrictions specified below:-

SCHEDULE 1

PROPOSED PROHIBITION OF WAITING AND LOADING AND PROVISION OF PARKING

Richmond, A6136 Station Road, south side, from its junction with the eastern side of Frenchgate (The Channel), eastwards for a distance of 37.5 metres - waiting prohibited between 8am - 6pm; Richmond, A6136 Station Road, south side from a point 37.5 metres east of its junction with the eastern side of Frenchgate (The Channel), eastwards for a distance of 14.5 metres, - Disabled Parking; Richmond, A6136 Station Road, south side, from a point 52 metres east of its junction with the eastern side of Frenchgate (The Channel), eastwards for a distance of 16.5 metres - Bus Stop.

SCHEDULE 2

REVOCATIONS

Reference 345 - Richmond, Station Road, south side, from its junction with the eastern side of Frenchgate, eastwards for a distance of 38.5 metres - No Waiting 8.00am - 6.00pm;
Reference 352 - Richmond, Station Road, south side, from a point 38.5 metres east of its junction with the east side of Frenchgate, eastwards to a point 70 metres east of its junction with the east side of Frenchgate - Bus Stop.
