When I try to save the file (It does save and can be renamed but the saved file excludes any "new" data typed into the form) the following error message is given "You cannot save data typed into this form. Topic / Chapter - Review of SD LP Designations - Section 5.9 - Specifically Development Limits

Question no. - 47a - How should Church Fenton grow and develop

Paragraph - Refers to Church Fenton map within Appendix 2 of the Plan document

**Actual Comment:** 

The existing Development Limit boundary for Church Fenton cuts through my garden at the rear of Heathcote, Northfield Lane excluding approximately half an acre of land. This area was granted planning permission for a change of use from agriculture to domestic curtilage in 2009 (ref no. 2009/0680/COU). This area of land is the artificial "hook" at the central / top section of the village's Development Area and is flanked on either side by private gardens that are within the Development Area. The anomaly of the classification of this area is extremely important as the maintenance of this large area of garden requires substantial amounts of garden machinery including a tractor mower for which I do not have the necessary storage facilities. When I investigated the possibility of obtaining planning permission to erect a small storage area for this purpose, I was informed in a pre application meeting with Simon Eades on 8th August 2012 that any approval outside the Development Area was extremely unlikely to be granted.

I would recommend that the current review of Development limits should recognise the extension of the Domestic Curtilage under approval 2009/0680/COU by removing the artificial cutback of the Development line after the extension for my neighbour at Bramblecroft and so accurately reflect the current position. This would end the current immediate veto of even the smallest of necessary planning applications.

These points have already been made to Selby District Council in a letter to the Council's Planning Officers Jessica Morris (by letter dated 9th October 2012) and Ryan King (by email on 7th February 2013).
