Dear Cheryl

Thank you for your message. I have to say that I am disappointed that your workshops during this round of consultation did not invite secondary villages, which have regular flooding problems of existing properties, to support your considerations of studies and growth in towns and service villages. Avoidance of a piecemeal approach I would have thought should be a primary purpose of Plan Selby. However I am pleased that you are updating the flood risk and infrastructure requirements and assume these will fully cover the need at Ryther.

Ryther submissions to the initial consultation highlighted the need for a pump installation to alleviate regular flooding by surface water. It should be noted this is an almost annual event for property owners and the village as a whole. This can only worsen with further development in service villages.

Specific points from Ryther PC on the current document are:-

Topic 4 on page 20 the paragraph does not include Ryther in the list of villages with specific issues needing additional infrastructure, will you update this please.

Question 25 should include EA, IDB and the flood alleviation for small scale needs such as at Ryther.

It is noted that some points from our original submissions have now been covered thank you, but not all. To assist, our original submissions for Plan Selby and the Infrastructure Plan are attached.

We shall be pleased to provide further input as needed

Thank you for your email.

A number of specific workshops were held with representatives from the 3 main towns and for those villages identified as Designated Service Villages (DSV) – those shown in the Core Strategy as capable of accommodating further growth . Ryther is not a DSV but instead identified as a Secondary Village which are those generally much smaller and less sustainable or else have no opportunities for continued growth (owing to a combination of flood risk and environmental constraints). Comments in response to PLAN Selby initial Consultation by Ryther Parish Council.

Chapter: 3 Key Issues	Topic: Providing Home	es (Flooding)
Question 9b	Paragraph: 3.24 3.25	Table d and e

PLAN Selby should be explicit with regard to the effect of development in high risk flood areas. For example the secondary village of Ryther suffers significant annual flooding. Flooding in Ryther is in the main from inland water courses, surface or ground water not from the river Wharfe. Flooding occurs when large flows from other areas into the river are prevented by closure of valves during river flood conditions. This is a mechanism that is well understood by EA and the Parish Council but often not by other agencies. The Ryther community with EA tries to reduce the effect when flooding occurs each year but often cannot, a situation that will worsen due to development in other areas without specific measures.

The significant development proposed in the designated service villages of Cawood, Church Fenton and Ulleskelf or the town of Sherburn in Elmet therefore will without additional control measures lead to increased annual flooding in Ryther including internal flooding of more property. Development in flood zones 1, 2, or 3 can cause this.

In such a known situation it can be considered a serious omission not to highlight in a separate PLAN Selby paragraph the known danger of consequential flood risk on other communities. Providing early awareness for subsequent users is an important factor in a document that is intended to inform. It is unacceptable to leave it to possible later consideration on a selected site by site basis and hope that safe solutions for all flooding will be provided through sequential testing. Without a specific control measure in PLAN Selby it could be more likely that sites will be allowed to develop over a number of years worsening serious flooding at Ryther, or in other communities, with no specific alleviation schemes to compensate.

Chapter 3: Key issues Topic 4: Infrastructure Plan

Question 25: Are there any infrastructure needs that have not been identified

Infrastructure needed at Ryther to combat increased flooding as a consequence of development in adjacent designated service villages is not currently identified. The intent of Plan Selby is to highlight important information in a District wide context in order to ensure appropriate decisions are made with knowledge of their impact. Necessary flood management infrastructure must therefore be included where flooding will increase as a result of development in designated service villages.

EA and Ryther Parish Council have already developed a low cost flood alleviation pumping scheme for installation on EA land. Although a part financial contribution has been provided from the EA Local Levy Fund, implementation cannot proceed without further funding. A Project Plan is available and quotations from contractors have been obtained. It is imperative that the scheme is implemented prior to any development in adjacent DSVs under PLAN Selby. Please include this project in infrastructure needs.

Strategic Flood Risk Assessment. An update is noted as planned. Flood alleviation for Ryther must be identified and recommended in this update.

Paragraph: Land Drainage 2.40, 2.41

Comment: In Paragraph 2.40 Land Drainage is correctly stated as contributing to flooding in several areas and that this is a 'flooding issue'. The Authority that is responsible for dealing with this flooding issue should be stated and their proposals included.

Paragraph 2.41 is in error, the Land drainage flooding issue stated in paragraph 2.40 will not be dealt with by the normal planning process. It should be stated as a strategic issue that needs dealing with by infrastructure provision otherwise communities will suffer increased flooding. The document is in error in this regard. Flooding at Ryther is an example of this.

Chapter 5: Settlements Topic: Designated Service Villages (flooding)

Question: 46, 47, 58 Paragraph: 5.64, 5.65, 5.90

Review paragraphs for designated service villages of Cawood (Para 5.64), Church Fenton (Para 5.65) and Ulleskelf (Para 5.90) should mention that their developments will increase flooding of adjacent villages such as Ryther unless prevention measures are undertaken. This is an important factor for choice of the sites.
