Good afternoon

Many thanks for the consultation which we have now received, regarding the Escrick Neighbourhood Plan consultation.

Whilst gratefully received, having reviewed the documentation attached to the consultation email (and being mindful of the extensive Local Plan work we already undertake with the Council's LP team), there is little formal comment to make at this point on behalf of the Secretary of State for Transport, and their primary interests.

It remains that any planned development already identified in the wider LP consultations for Selby District has been accounted for in the most recent consultation of November 2021, and that the council has our extant comments already. Should new development be publicly forthcoming (which sit outside of the existing proposed LP), we would look to review this with yourselves in the usual manner and any supporting mitigation it may require.

The current consultation shows the wider aspirations of the neighbourhood plan in a positive light, and this is welcomed. With an identified rate of 63% outbound commuter traffic, it is expected that this (along with the other various neighbourhood plans) will link to the growing congestion and impacts on the SRN which the Council will need to address in their IDP proposal to ensure a sound local plan infrastructure offering. At this time therefore, I will continue my work with the Council to identify specific sites which may have a significant impact to the continued safe operation of the Strategic Road Network (most likely focusing on the A64), and furthermore ensure the Council then formulates a methodology to ensure any financial contributions are collected from developers to provide any necessary mitigation on the SRN.

National Highways will also remain vigilant to the aggregated impact of all local Parish aspirations, when determining our position on the Local Plan for Selby District Council, now, and in the future.
