#### Dear Zoe

I have now had the opportunity to consider your latest email.

The Council has considered your original representation dated 21 February and accompanying Appendix emailed on 25 February. Following discussions at a meeting on 10 March you then provided further clarification that some of your concerns had been addressed but the issue relating to text referring to the Habitats Regulations Assessment (HRA) were outstanding.

In response, the Council published a set of Editorial Changes and Minor Amendments in May 2011 incorporating an amendment to add an additional paragraph after 1.29 to include references to the HRA, capturing the spirit of your requested amendments. We consider that wording is appropriate to make the plan sound. We consider that it is unnecessary and inappropriate to include the precise wording in full here as you request. It would provide excessive reference to one aspect being considered above other aspects. The Habitats Regulations stand alone and it is not for the Core Strategy to duplicate this.

You will need to decide what you would like to put before the Inspector if you are submitting a Written Statement in response to the Inspector's invitation in relation to the published Matters and Issues by the 2 September deadline; and decide if wish to attend the Hearing.
