Pre-Submission Publication Selby District Local Plan (August 2022)

What is the Selby District Local Plan?

The Selby District Local Plan sets out where new development will take place, as well as the local planning policies for determining planning applications and other development applications submitted to the Council. Sites allocated to be developed as well as areas for protection are identified on the Policies Map.

What is the Pre-Submission Publication Local Plan?

The Pre-Submission Publication Local Plan (or just known as the Publication Plan) is the version of the Local Plan that the Council proposes to formally 'submit' to the Secretary of State for Examination. The Council has considered all the responses received at all previous consultations in 2020 and 2021 and has made its decision regarding the policies and development proposals based on the evidence provided. By being involved in the Local Plan process at these earlier informal stages of consultation, you will have helped to shape the development direction of your neighbourhood and the District.

What are the Plans for Ulleskelf?

The proposals for Ulleskelf are shown on the map overleaf. Ulleskelf is designated as a Tier 2 Village in the settlement hierarchy. Land East of Bell Lane (ULLR-K) is allocated for 29 new homes where a minimum of 20% will be affordable. It is important that the new dwellings are well designed and contribute to the unique character of the village in terms of form, scale, density, layout and mix of building materials, minimising the impact on views from the wider countryside to the south. S106 financial contributions will benefit the local educational facilities to meet demand arising because of the development.



How did you decide on which sites to choose for allocations?

Landowners and developers submitted sites to us which have been assessed through the Site Assessment Methodology. This plan (right) shows all the sites we had to assess and to choose from.

What is this consultation?

This consultation is the formal consultation on the Publication Local Plan (known as Regulation 19 stage) before the Local Plan is formally Submitted to the Secretary of State for Examination by an independent Planning Inspector. The Publication consultation stage is your opportunity to say whether you think the Local Plan complies with the relevant legal requirements including



the Duty to Cooperate and is 'sound' (these are defined in the Government's National Planning Policy Framework).
